THE MINISTER OF STATE IN THE MINISTRY RESOURCE OF HUMAN DEVELOPMENT (DEPARTMENT YOUTH AFFAIRS AND SPORTS) WITH ADDITIONAL CHARGE OF THE MINIS-TER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS (SHRI MUKUL WASNIK): (a) The total allocation of Sports Authority of India (SAI) for the current year is Rs. 40.5ft crores which includes Rs. 26.50 crores of Plan funds and Rs. 14.00 crores under Non-Plan. The anticipated receipts are Rs. 2.94 crores.

(b) Asum of Rs. 3.17 crores (7.3 percent) has been earmarked for infrastructure development of stadia by SAI. This excludes the expenditure on maintenance of infrastructure.

- (c) The Antiquities and Art Treasures Act, 1972 came into effect from 5th May, 1976. The sections 14 and 16 lay down clear procedure for registration of antiquities within six months of the Notification of the Antiquities and Art Treasures Act or within 15 days of the date on which one comes to own, control or possess such antiquity. Besides under the Section 18 of the Antiquities and Art Treasures Act, registration does not apply to any antiquity kept in a Museum or in an Office or in an Archive or in an educational or Cultural Institution owned, controlled or managed by the Government or by any local authority or by any such body as the Central Government may, for reasons to be recorded in writing, approve for the purpose of this section by general or special order. The Registration Officers working under the jurisdiction of various State Governments and Territories are assigned with Union work.
