Setting up of Technical Training Institute in Maldives

2197. SHRI SURESH KALMADI: Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that the Hindustan Machine Tools are setting up a technical training institute in Maldives; and
- (b) if so, what are the details thereof and the total cost involved therein?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (DEPTT. OF INDUSTRIAL DEVELOPMENT) WITH ADDITIONAL CHARGE OF THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (DEPTT OF HEAVY INDUSTRY) (SMT. KRISHNA SAHI): (a) and (b) The Govt. of India under its Grants-in-Aid programme is assisting the Govt. of Maldives to set up a vocational training institute, viz. Maldives

Institute of Technical Education in Male. HMT (International) has been entrusted the task of implementing the project on a turn key basis. This institute will train 112 school leavers every year in various trades. The duration of the course will be 2 years. The total assistance from India will be to the extent of Rs. 10.27 crores. The Govt. of Maldives will be putting in an amount of US\$ 120,000 towards additional civill works and US\$ 709,000 towards local expenses.

Winding up of DGTD

The restructuring envisaged involves transfer and absorption of several Directorates to/by concerned Ministries/ Departments as also abolition of some Directorates and Regional offices. In order to ensure that the process of identification/transfer/ redeployment/absorption of personnel is expeditious and the related service/cadre issues are smoothly resolved, Government have constituted a Committee in the Department of Industrial Development.

KRISHNA SAHI): (a) MARUFF UDYOG LIMITED (MUL) is now a non-Government company in terms of the Companies Act.

- (b) The present equity-holding of Government in MUL is Rs. 65,80,18,100. MUL has not suffered any loss in any financial year so far.
- (c) and (d) MUL utilised Rs. 721.18 crores of free foreign exchange (net of foreign exchange earnings) for importing components till 31-3-92. From March, 1992, LERMS was introduced and Government stopped giving foreign exchange to MUL. Since then, like any other Indian Company, MUL is purchasing foreign exchange from the market.
