Setting up of National Institute of Consumer Affairs

The object of the proposed institute is to undertake and assist in organisation of training and study courses, conferences, seminars; to undertake research; to establish and maintain libraries and information services; to conduct surveys and studies etc.

As per information available on that date 9698 cases are pending in the Consumer Fora in Maharashtra, out of which 2029 cases are pending with the two consumer fora in Bombay City. Non-availability of (1) qualified persons for appointment as President of the District Fora: (2) technical staff like stenographers; and (3) suitable accommodation are some of the reasons for dealy in disposing of the. cases.

The measures being taken by the State Government of Maharashtra in reducing the delay in deciding cases include appointment of full-time Presidents, training of non-judicial members of the consumer fora, filling up staff vacancies, location of suitable accommodation and creation of necessary infrastructure.
