

**Computer System lying unoperationsi at
Telecom Research Centre**

2541. SHRI RAMACHANDRAN PILLAI: Will the Minister of COMMUNICATIONS be pleased to state:

(a) whether it is a fact that the computer system comprising of a main frame and a mini computer installed at the erstwhile Telecommunication Research Centre in July 1988 at the cost of Rs. 284.80 lakhs lying idle; and

(b) when it became operational?

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (SHRI SUKH RAM): (a) Yes, Sir.

The mainframe and the minicomputers were installed at erstwhile Telecommunication Research Centre for research projects. These projects were subsequently transferred to C-DOT who did not have any use of these computers.

(b) The system became operational in July, 1988.

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (SHRI SUKH RAM): (a) and (b) Tenders were invited from Indian companies with a view to licence cellular mobile telephone service in Bombay, Delhi, Calcutta and Madras on a non-exclusive basis. 8 bidders, two in each city, were provisionally selected. Some of the unsuccessful bidders filed a civil writ
