2838. श्री राम नरेशा यादव : क्या स्वास्थ्य और परिवार काल्याण मंत्री यह बताने की कृषा करेंगे कि :

- (क) क्या सरकार को इस बात की जानकारी है कि निश्व के कई देशों में प्रतिबंधित लगमग 515 दवायें मारत में खुले आम बेची जा रही है:
- (ख) यदि हां, तो इन प्रतिबंधित दवाओं की बिन्नी रोकने के लिए सरकार ने क्या उपाय किये हैं; और
- (ग) देश में इन दवाओं को बेचने वाली कम्पनियों की संख्या क्या है तथा उनके नाम क्या-क्या है और उनके विरुध्द क्या कार्यवाही की गई है ?

स्वास्थ्य और परिवार कल्याण मंत्री (श्री की॰ शंकरानन्द): (क) से (ग) यह सही नहीं है कि कई देशों में प्रतिबंधित 505 औषध्यां भारत में बेची जाती हैं। 44 औषध्यां जिनके बारे में विश्व स्वास्थ्य संगठन की यह सूचना है कि उन औषध्यों का कुछ देशों में उपयोग रोक दिया गया है उनमें से 11 औषध्यों का सरकार ने विशेषजों तथा औषध्य तकनीकी सलाहकार बोर्ड की सलाह पर प्रतिबंधित कर दिया है, 26 औषधों को विपणन की सलुमति नहीं दी हैं तथा बाकी सात अनुमत औषधों का विपणन जारी रखने की अनुमति दी हैं। वृंकि 7 औषधों को विप्रेषकों दारा भारत में उपयोग समझा जाता है, किसी प्रकार की कार्रवाई का प्रश्न नहीं उठता।

## Outbreak of Measles and Gastroenteritis in Uttar Pradesh

2839. DR. NAUNIHAL SINGH: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether Government are aware of the outbreak of measles and gastroenteritis in the State of Uttar Pradesh, if so, how many persons died as a result thereof and the names of the districts inflicted;
- (b) what steps Government have taken to contain the two diseases, the details thereof; and
- (c) whether there have some lapses on the part of the State Health Department to prevent such a scourage, if so, the details and reasons thereof?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARA-NAND): (a) to (c) The information is being

collected and will be laid on the Table of the House.

## Directory of Potential Blood Donors

2840. SHRI MENTAY PADMANABHAM: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether Government's attention has been drawn to the news-item in the Times of India dated 15-7-93 captioned 'ALIGARH'S LIFELINE OF GOOD BLOOD';
- (b) whether Government propose to encourage the formation of groups of people motivation to build up a directory of potential blood donors:
- (c) what steps Government have initiated to make available clean, disease-free blood to patients all over the country; and
  - (d) the details of such concrete steps?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARANAND): (a) and (b) Yes, Sir.

(c) and (d) Government have started a comprehensive programme to ensure availability of infection-free blood all over the country. Testing of Blood for HIV has been made mandatory and for testing of blood 180 Zonal Blood Testing Centres have been set up all over the country. Linkages have been provided to all Blood Banks with the Zonal Blood Testing Centres. For emergency situation Rapid Testing Kits have been provided.

#### W. H. O.s concern for Health Care

2841. SHRI V. HANUMANTHA RAO: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether W. H. O. is given maximum emphasis regarding health care;
- (b) the details of priorities as expressed by W. H. O.;
- (c) whether many officers of his Ministry are on deputation to W. H. O.; and
- (d) if so, whether there is any interaction between W. H. O. and your Ministry?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARA-NAND); (a) Yes, Sir.

- (b) As per the W. H. O. priority areas for the biennial 1994-95 include:—
  - the health of man in a changing environment;
  - proper food and nutrition for a healthy life;
  - intergrated disease control as part of overall helath care and human development;
  - dissemination of information for advocacy and for educational, managerial and scientific purposes;
  - intensified health development action in, and support to, countries most in need.
- (c) and (d) No, Sir. However, there is continuous interaction between Govt. of India and the W. H. O.

## Import of Contraceptive Devices from American Company

2842. SIIRI KRISIINA KUMAR BIRLA: Will the Minister of HEALTII AND FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that lakhs of contraceptive devices imported from an Amarican Company in Mid 1992 were found sub-standard and were released for the family planning programmes;
- (b) whether it is also a fact that lakhş of contraceptives worth millions of dollars purchased from the same American Company earlier were also defective and sub-standard;
- (c) if so, what is the estimated amount spent on the import of the contraceptives;
- (d) whether any inquiry into the reasons for accepting and releasing the defective contraceptives has been made;
  - (e) if so, what are the details thereof; and
- (f) whether any responsibility for the lapse has been fixed by Government?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARA-NAND): (a) 21.70 lakh pieces of Copper-T received as commodity assistance from USAID in February-March, 92 were not found substandard.

(b) and (c) Between December, 90 and March, 91 components for assembling 5.25 million pieces of Copper-Ts were received by M/s. Hindustan Latex Ltd. (a Public Sector Undertak-

ing) from M/s. Finishing Enterprises Inc., USA. As these were received as commodity assistance from UNFPA no financial expenditure was incurred by the Govt. of India on imports. Some of these components on test in India did not conform to the US-FDA approved Population Council standards as per terms of the agreement and, therefore, could not be used.

(d) to (f) UNFPA was requested to take back these components but regretted their inability to do so. A Technical Committee consituted under the Chairmanship of Drugs Controller (India) has after testing the components made recommendations that components which conform to BIS specifications may be used in the National Family Welfare Programme.

### World Bank aid for AIDS

2843. SIRI H. HANUMANTHAPPA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether it has come to the notice of Government that funds sanctioned to the States by the World Bank had not been utilised by them for controlling the AIDS;
- (b) if so, whether any investigation has been made into it to find out the reasons why the States were unable to utilise this money on AIDS; and
- (c) the names of the States which have failed to utilise the money sanctioned by the World Dank for the specific purpose of AIDS programme?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARA-NAND): (a) to (c) Funds released to the various State Government and Union Territories under the National AIDS Control Programme could not be fully utilised by several of them due to the late start of the programme in 1992-93. All the financial sanctions have been revalidated to facilitate their use during the current year. According to the established procedure, expenditure actually incurred is reimbursed by the World Bank subsequently: Thus, the question of non-utilisation of World Bank funds does not arise.
