## Nexus between Film Producers and Underworld

2340. SHRI VIJAY J. DARDA: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) whether Government are aware of the nexus between film producers and underworld;
  - (b) if so, the details of investigations carried out and the outcome thereof;
- (c) whether Government are committed to declare film production as an industry and provide such facilities as are available to other industry;
  - (d) the details of action plan formulated in this regard; and
- (e) the details of fresh policy measures taken/proposed to address the major problem faced by the film industry?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRIMATI SUSHMA SWARAJ): (a) to (e) "Police" is a State subject as per the Seventh Schedule to the Constitution of India and, as such, registration, investigation, detection and prevention of crimes is primarily the responsibility of the State Governments;

In order to facilitate a greater flow of institutional finance to the film industry, Notification dated 16.10.2000 has already been issued by the Ministry of Finance, whereunder the "Entertainment Industry including films" has been specified as an approved activity for accessing finance under the IDBI Act. The Industrial Development Bank of India and the Reserve Bank of India have also evolved guidelines to enable banks and financial institutions to fund proposals for financing of film production.

The merit of each complaint is looked into, if necessary through an inquiry, and action is taken on the basis of the existing guidelines.

#### Plan to increase the Potential of DD's Infrastructure

THE MINISTER OF INFORMATION AND BROADCASTING (SHRIMATI SUSHMA SWARAJ): (a) and (b) The present infrastructure of Doordarshan, built over a period of time, comprises 52 studios and 1203 transmitters, located in various parts of the country. Increase in the potential of Doordarshan's infrastructure, both in terms of reach and quality, is a continuous process, and schemes in this regard are formulated and implemented by Prasar Bharati from time to time, within the constraints of resources available and inter-se priorities. At pesent, for further expansion of the Doordarshan network, 12 studios and 229 transmitters are at various stages of implementation.
