(b) and (c) Government has promulgated the Consumer Protection (Amendment) Ordinance, 1993 on 18.8.1993 which enables the State Governments and UT Administrations to set up more than one District Forum in a District depending upon the workload. However, there is no provision to set up more than one State Commission in a State in the Ordinance. The Act does not provide for setting up of State Commission District Forum specifically for claims against Super Bazar.
