- (a) what is the annual working plan size for each state and Union "Territories" for the year 1992-93 and 1993-94 alongwith Projections wherever available;
- (b) what are the reasons that despite proclaimed policy of Government to conserve forests, it has failed to do so, particularly in union territories and in Andaman where Annual Plan is designed in a manner so as to cater to needs of local industry; and
- (c) if not, what are the reasons that working plan of Andaman still continues to be planned on commercial consideration than on conservation promotion?

(b) and (c) The total green cover in the country increased from 640134 sq. km, in 1989 to 640694 sq. km in 1991.

Due to consistent efforts in forest conservation, the extent of green cover in Andaman and Nicobar Islands has been maintained at 7624 sq. km. as against the recorded forest area of 7171 sq. km in a total geographical area of 8249 sq. kms. 86 9 per cent of geographical area of Andaman and Nicobar Islands is under forest.
