THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI K. C. LENKA): As compared to the corresponding period of the preceding year 1992-93, there has been increase of Rs. 502.73 crores in total revenue earnings' which includes increase of Rs. 124.80 crores in passenger earnings. However, with reference to the proportionate target of first quarter of the current financial year 1993-94, there has been a shortfall of Rs. 232.13 crores in revenue earnings. The shortfall in revenue earnings mainly relates to Goods traffic and is attributable to less offering of traffic from the core sectors. There is also drop in passenger earnings compared to targets which is mainly due to anticipated growth not materialising.

Construction of Dimapur Railway Station

- 4120. SHRI VIZOL: Will the Minister of RAILWAYS be pleased to state:
- (a) Whether it is a fact that Dimapur Railway Station was constructed by Britishers during pre-independence days:
- (b) if so, the year of its construction with details of facilities provided at that time;
- (c) whether it is a fact that no extension of these facilities has been made since then although traffic has increased many folds;
- (d) whether Government propose to take some action in this regard, and
- (c) if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI K. C. LENKA): (a) Yes, Sir.

- (c) to (e) The facilities at this station have been augmented whenever so warranted by growth in passenger traffic. Recently, renovation/face lifting of the station building has been completed at a cost of Rs. 15.77 lakh.
