## Poor state of PDS in North-Eastern States

## 6. SHRIMATI KAMLA SINHA: DR. BAPU KALDATE:

Will the Minister of CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION be pleased to state:

- (a) whether Government are aware of the severe shortcomings in the Public Distribution System in the North-eastern slates:
- (b) whether the inferior quality of foodgrains and inadequate storage facilities are adding to the problems of the region; and
- (c) if so, what steps Government have taken or propose to take in this regard to ensure the adequate supply of essential commodities and foodgrains to the Northeastern states?

THE MINISTER OF CIVIL SUPPLIES CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI A. K.

ANTONY): , (a) to (e) The entire requirement of foodgrains and other PDS commodities for the North-Eastern States is being transported from outside this region by rail and road. The long distances involved coupled with the difficult terrain etc. do cause difficulties for the Public Distribution system in this region. It is not true that inferior quality of foodgrains are being supplied to the North-Eastern States. Central Government has taken a number of steps to improve the supplies for the Public Distribution System in the North-Eastern States.

The Food Corporation of India makes efforts to keep adequate stocks in the region

to meet contingent requirements during the monsoon season. Priority has been given for creation of adequate storage infrastructure by the FCI in the North-Eastern States. Central Government provides financial assistance to State Governments for creation of storage capacity in Revamped PDS areas and all North Eastern States on liberal terms. Similar assistance is also given to the State Governments for purchase of vans which could be used either as mobile fair price shops or for transportation of PDS commodities to the door step of the fair price shops.

The functioning of PDS in North-Eastern States is reviewed from time to time in consultation with the concerned States
