THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION WITH ADDITIONAL CHARGE OF THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KAMALUDDIN AHMED): (a) Yes Sir. The Hon'ble Minister of Civil Supplies, Consumer Affairs & Public Distribution had a review meeting with the major trade associations and consumer organisations on 7th June, 1993 in which he requested the industry to submit concrete proof of having passed on the concessions announced in the Budget to consumers.
