वस्त्र मंत्रालय के राज्य मंत्री (श्री जी० वेंकटस्वामी) : (क) सरकार ने एकीकृत ग्रामीण विकास कार्यक्रम, स्व-रोजगार के लिये ग्रामीण युवकों को प्रशिक्षण, इंदिरा आवास योजना और जवाहर रोजगार योजना जैसी चालू योजनाओं में हथकरघा बुनकरों की कवरेज को बढ़ाने के लिये एक कार्य योजना की घोषणा की है ।

(ख) और (ग) इसके प्रभावी कार्यान्वयन के लिये राज्य सरकारों के संबंधित प्राधिकारियों को 18 मई, 1993 को विस्तृत परिपत्र जारी किये गये हैं । राज्य सरकारों को यह भी निदेश गये हैं कि राज्य हथकरघा अभिकरणों के परामर्श से लाभ पाने वालों की पहचान करें । उनसे यह भी अनुरोध किया गया है कि डी०आर०डी०ए०/जिला परिषद को हिदायतें जारी करें कि इस योजना को वर्ष 1993-94 से आरम्भ कर दें ताकि लक्षित हथकरघा बुनकरों को आगामी तीन वर्षों के दौरान सहायता दी जा सके ।

THE MINISTER OF STATE OF THE MINISTRY OF TEXTILES (SHRI G. VENKAT SWAMY): (a) and (b) 26 Mills are reported to be temporarily closed as on 31-3-93 due to various reasons such as frequent lockouts, strikes, financial difficulties etc., State-wise break-up is as under:—

THE MINISTER OF STATE OF THE MINISTRY OF TEXTILES (SHRI G. VENKAT SWAMY): (a) Out of the total quota of 17,855 lakh bales, released during Cotton Year 92-93 the quantity shipped (exported) as on 28-6-93 is 10,325 lakh bales.

(b) As on 21-7-93, CCI has contracted 7,23,515 bales and shipped 5,63,154 bales.
