(d) to (g) In Feb., 1992, World Bank approved a Loan to Govt of India for Power Utilities Efficiency Improvement Project amounting to US \$ 265 Million, the proceeds of which are to be on-lent to PFC, who would re-lend the same to eligible State Electricity Boards. The project will cover areas such as Upgrading of Transmission and Distribution System, System Renovation, Environmental Upgrading of Power Plants, and Institutional Strengthening of Power Utilities, etc. The Loan became effective in March, 1992. There has been no drawal out of the Loan by PFC so far for reasons such as the time required in preparation of schemes, appraisal, finalisation of bid documents etc. It is envisaged that the drawals under the Loan would commence during the current financial year.

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (SHRI SUKH RAM): (a) Yes Sir. The Department of Telecommunications owes some amount to various manufacturers of Telecom equipment.

(b) The Department of Telecommunications including Mahanagar Telephone Nigam Limited has purchased equipment worth about Rs. 4500 crores and there are some outstanding bills for payment amounting to approximately Rs. 262 crore. The reasons for non-payment are inadequate funds, limitations on drawing limits of various Telecom Circles, lack of complete documentations required to be attached with the claims etc.
