OF CULTURE) (KUMARI SELJA): (a) to (c) According to the information furnished by UGC, the Commission had convened a special meeting of Vice-Chancellors/ Directors of Universities/Deemed Universities in New Delhi in May, 1993, to discuss more effective implementation of the revised Programme of Action-1992, on the modified National Policy on Education-1986, in so far as it relates to higher education. The Chairman. UGC, while welcoming the participants mentioned that there are four partners in the work of implementation of NPE-1992, namely Government of India, UGC, State Government and Universities and their respective roles have to be delineated so that there is clarity in the thinking of all the four agencies and NPE as also POA can be systematically implemented. The Government welcomes the initiative taken by the UGC to motivate and urg, the Universities for effective implementation of the NPE and POA. There is nothing wrong in the reported statement of the Chairman UGC in the Oonferrtuce of Vice-Chancellors.

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDU-CATION AND DEPTT. OF CULTURE) 'KUMARI SELJA): (a) and (b) No. Sir. The Department of Ancient Indian History and Culture, University of Nagpur and Archaeological Survey of India had carried out excavations at Pauni, District Bhandara, Maharashtra during the seasons 1968-69 and 1969-70. The excavation brought to light Buddhist stupas and other structures datable to c. 3rd Century B.C. to 3rd century A.D., Chayastambas, Mn'"-ya-Brahmi inscriptions, copper place of Vakatakas and antiquities inclning sculptures of Buddhist theme in Sunga style, Satayahana-Kshatrapa coins and ceramics such as Northern Black Polished Ware and Red Polished Ware. Since the Cultural sequence of the site has been established and the excavation report has been published, no further excavation is proposed at Pauni by the Archaeological Survey of India.
