- (b) if so, what is Government's view in this matter:
- (c) whether Government are aware of the suggestions made by the EDUCARE Foundation in this regard particularly exempting children from studying more than one language and allowing them extra time in exams;
- (d) whether Government also know the measures taken by Karnataka Government in this regard;
- (e) if so, what in the perception of the Central Government in these remedies; and
- (f) whether Government would like to set up an experts panel to evaluate the incidence and suggest cares?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDUCATION AND DEPTT. Op CUT TURE) (KUMARI SELJA): (a) Yes, Sir

(b) Dyslexia is one of the conditions which constitute specific learning disability, including reading difficulty, in children. Dealing with learning difficulties, including reading difficulties, is already a part of general teacher training programmes. The Centrally Sponsored Scheme of

Integrated Education for the Disabled, Children (IEDC) also covers children with learning disabilities.

- (c) Yes, Sir.
- (d) and (e) The Central Government is not aware of the measures taken by the Karnataka Government.
- (f) There is no proposal for setting up of an experts panel.

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDUCA-TION AND DEPTT. OF CULTURE) (KUMARI SELJA): (a) and (b) Kendriya Vidyalaya Sangathan has intimated that the ratio of Direct Recruitment quota and Departmental Promotion quota in the Recruitment Rules for teachers of Kendriya Vidyalaya Sangathan has been fixed on the basis of requirement of teachers in different subjects in the schools spread all over India. The Recruitment Rules of Kendriya Vdyalaya Sangathan, therefore, cannot be compared with those of the Union Territories.
