(KUMARI SELJA): (a) According to Delhi Administration the prescribed teacher student ratio at primary stage is 1:40. In the primary schools of Delhi Administration the ratio at present is 1 : 39 and in Municipal Corporation Schools it is 1.40.6.

(b) and (c) There is no shortage of trained teachers. For the new posts that are created for catering to increased enrolment and for vacancies occuring In normal course, regular recruitment of qualified teachers is made from time to time.

# Acquisition of DAV College Hostel at Kanpur

The response from remaining universities of UP is awaited.

(c) Admissions are decided by the concerned universities themselves. Hence no action can be taken by the UGC in this regard.
