

माध्यमिक शिक्षा के व्यावसायीकरण की केन्द्रीय प्रयोजित योजना के अंतर्गत राज्य सरकारों/केंद्र शासित प्रदेशों द्वारा व्यावसायिक पाठ्यक्रम शुरू किए जाते हैं। पूर्णकालिक और अंशकालिक शिक्षकों की नियुक्ति तथा उनकी सेवा शर्तों को निर्धारित करने का कार्यसम्बद्ध राज्य सरकारों/केंद्रशासित प्रदेशों द्वारा किया जाता है जिनकी यह प्रत्यक्ष जिम्मेदारता होती है।

मध्य प्रदेश व्यावसायिक शिक्षक संघ से व्यावसायिक पाठ्यक्रमों से जुड़े अंशकालिक शिक्षकों की समस्याओं के संबंध में प्राप्त अभ्यावेदन को तदनुसार उचित कार्यवाही के लिए मध्य प्रदेश सरकार के शिक्षा विभाग के पास भेज दिया गया।

Departmental Promotion of Primary and T.G.Ts. (Humanities and Social Sciences)

4466. SHRI GAYA SINGH: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it is a fact that Primary teachers and Trained Graduate Teachers (Humanities) and Social Sciences) in Kendriya Vidyalayas have been lagging behind in departmental promotion to their counterparts in Science/Mathematics;

(b) if so, the Seniority Numbers to which Primary Teachers and TGTs. of these streams have been promoted as on date; and

(c) the reaction of the Kendriya Vidyalaya Sangathan thereto?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDUCATION AND DEPTT. OF CULTURE) (KUMARI SELJA): (a) to (c) Kendriya Vidyalaya Sangathan has intimated that the vacancies of TGTs in Kendriya Vidyalaya Sangathan are filled up 66.2/3 per cent by direct recruitment and 33.1/3 per cent by promotion from amongst Primary Teachers depending on the discipline of their Graduation. Similarly from T.G.T. to P.G.T., the promotion quota is 33.1/3 per cent. T.G.Ts. have, however, the

option to change the stream in case they possess the Master's Degree in the relevant subject. As the promotions are purely based on the vacancies in the respective higher grades, it is not possible to provide equal promotional changes for all the streams in T.G.Ts. and P.G.Ts.

Mathematics subject in Kendriya Vidyalayas

4467. SYED SIBTEY RAZI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether teaching of mathematics subject in Kendriya Vidyalayas in Classes 9th and 10th serves no utility to students joining Commerce and Humanity streams in Class XIth except to students in Science streams;

(b) whether teaching of present mathematics books in Kendriya Vidyalayas in Classes IXth and Xth serves no useful purpose to students in the lives after completion of their school studies from Commerce and Humanity streams;

(c) whether present books of mathematics subject are very tough according to teaching standards in Kendriya Vidyalayas;

(d) whether Government propose to make these mathematics books more simple, useful and optional subject of teaching;

(e) whether Government propose to issue some instruction to Kendriya Vidyalayas to hold extra classes either before schools timings or after schools timings for mathematics subject on some nominal charges to make students to understand the tough subject; and

(f) if so, details thereof separately for (d) and (e) and if not, reasons therefor
