Training to youth of Madhya Pradesh

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RE-SOURCE DEVELOPMENT (DEPART-MENT OF YOUTH AFFAIRS AND SPORTS) WITH ADDITIONAL CHAR-GE OF THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMEN-TARY AFFAIRS (SHRI MUKUL WAS-NIK): (a) and (b) Yes, Sir. A scheme entitled SCHEME FOR TRAINING OF YOUTH was introduced in 1986-87 and an amount of Rs. 261.5 lakhs has been spent under this scheme.

(C) Ever since the inception of the scheme, an amount of Rs. 4.7 lakhs has been released to the State of Madhya Pradesh to train 264 youths.

(d) There are no permanent training schools under this scheme. The Department releases money to the State Government as well as other reputed voluntary organisations on the basis of viable proposals received and the assistance is limited to the duration of the project.
