(d) The following strategies are being adopted to increase export earnings from marine products sector :

- (1) Development of deep sea fishing and diversified fishing for stepping up export production;
- (2) Stepping up production by culture fisheries;
- (3) Induction of new technology and value addition;
- (4) Modernisation of processing facilities, quality upgradation and waste reduction; and
- (5) Aggressive market promotion measures.

#### Discharging of export obligation by Indian Exporters

- (a) whether Government are aware that many Indian exporting firms are taking it easy in discharging their export obligation;
- (b) whether the exporting firms are resorting to such act by taking advantage of the certain concessions given to them by Government;
- (c) whether Government are taking any action to monitor the exporting firms for fulfilment of export obligation; and
- (d) if so, what are the details thereof?

(c) and (d) Whenever any default is noticed, punitive action under the Foreign Trade Development and Regulation Act, 1992 is initiated which can result in imposition of fiscal penalty as well as debarment.

- (f) if the answer to above be in the negative, what steps are being taken to maintain market equilibrium ?
