#### **Fertilizer subsidy to States**

Will the Minister of AGRICULTURE be pleased to state :

(a) whether Government propose to release fertilizer subsidy to the States for the Kharif crop ; if so, by when it is likely to do so ;

(b) what is the basis of fertilizer subsidy distribution among various States with details thereof ;

(c) what is the total amount of fertilizer subsidy available for the Kharif crop and how much was distributed last year ;

(d) whether the fertilizer subsidy is given to various States in lump sum or in instalments ; and

(e) whether the amount of fertilizer subsidy meets the total demand of the various States ; if not, what are the gaps left in each case ?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ARVIND NE-TAM) : (a) Government have released the first instalment of funds to State/UT Governments towards implementation of the scheme of

concessional sale of decontrolled fertilizers.

(b) and (c) Rs. 356 crores has been provided under the scheme for Kharif '93. Allocations to State/ U.Ts. have been made based on fertilizer demand projections made by the States/UTs as also trends in past consumption.

(d) Funds required for the implementation of the scheme is released in instalments based on sales utilisation of earlier releases.

(e) The country's phosphatic fertiliser requirement is met through indigenous production and imports. Funds provided under the current year's scheme covers indigenous product only in order to make it competitive with the cheaper imported product. The scheme however, covers MOP, though it is entirely imported as the market prices of this product is high.
