

THE MINISTER OF CIVIL AVIATION AND TOURISM (Shri Ghulam Nabi Azad) : (a) to (c) Kulu-Manali region of Himachal Pradesh has been included in the travel circuit of Kulu-Manali-Leh which has been identified in the National Action Plan for tourism by the Central Govt. The State Govt, of Himachal Pradesh has to formulate suitable projects proposal for infrastructural development for the region and field the same to the Central Government for extending financial assistance. So far, no proposal has been received from the State Govt, during 1992-93.

**Starting Vayudoot service from
Trivandrum and Madurai**

THE MINISTER OF CIVIL AVIATION AND TOURISM (Shri Ghulam Nabi Azad) : (a) to (c) Shortage of aircraft capacity and constraint of other resources do not at present permit starting of air services between Kanyakumari and Trivandrum/Madurai by Vayudoot.

नागर विमानन और पर्यटन मंत्री (श्री गुलाम नबी अजाद) : (क) वायुदूत के विमान ब्रेडे में इस समय ब्राड डोर्नियर-228 और ब्राड एवरो एच. एस.-748 विमान हैं। इनमें से चार डोर्नियर और तीन एवरो परिवालन में सगे हुए हैं। इन विमानों के लिए नागर विमानन महा-निदेशक द्वारा वैद्य उड़ान-योग्यता प्रमाण-पत्र जारी किए गए हैं।
