of over 175 Indian students is at stake. It has .also come to my. notice .that the authorities of the Uzbekistan Government have even stopped giving ration to them and, in some cases, the Indian students were asked to vacate the hostel accommodation and to leave for Moscow. The students are not even allowed to hold meetings among themselves. The problems of the Indian s'udents were brought to the notice of the hon. Minister of State for External Affairs during his visit to Tashkent on 9-10-92 and he readily agreed to take proper action. But I was astonished to note that various cultural, scientific and research agreement were signed between these two countries after the visit of the Minister but no action has been taken by the Government of India to solve the problem of the Indian students there. It is, therefore, requested that the Government of India should initiate dialogue with the Government of Uzbekistan to solve this issue. The Government should ensure that no chance is given to any Government to play with the future of the bright students of India whether in Uzbekistan or anywhere else.

Re. Fire in A.I.I.M.S.

SHRI JOHN F. FERNANDES (Goa) Madam, I want to refer to the tragedy which took place in the capital yesterday. The All India Institute of Medical Sciences was on fire. Prima facie, it appears that it was not a natural tragedy but a man-made tragedy. It has been reported that sophisticated research equipment, including computers and miscroscopes worth crores of rupees, was destroyed. The major tragedy of this accident was that the software which contained the research of the students of over a decade destroyed. We do not know whether this research software was duplicated and the copies were kepi in safe custody. The whole episode appears to be very funny. The sprinklers were not functioning. The fire extinguishers were missing from the premises. The fin exits were closed, apparently, for fear o1 theft. This appears to be a cooked-uj story. The destruction of these micros copes and computers is costing crores of rupees. I feel that the House should in vestisate in the matter. Yeslerday, it was

reported that the Health Minister had given direction to enquire into the matter. I think that this House also should go into the matter.
