Inconvenience caused to Public due to Traffic diversions

Will the Minister of HOME AFFAIRS be pleased to state : (a) whether it is a fact that a great inconvenience is caused to thousands of office goers and other public parti-

cularly ladies and children who have to travel long distance even during peak traffic hours when traffic diversions and restrictions are imposed on account of visits of VIPs and VVIPs including foreign dignitaries to samadhis of departed leaders to pay homage on their birth and death anniversaries at Rajghat Samadhi Complex. New Delhi;

(b) whether it is also a fact that the behaviour of police officials posted at traffic intersections on the routes to check and divert traffic is more deplorable and cause of great inconvenience to the public; and

(c) if so, what steps Government propose to take to carve out separate VVIPs routes to Rajghat Samadhi Complex and other areas where VIP or VVIP visit to avoid inconvenience to public and traffic chaos which occurs frequently in New Delhi?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P.M. SAYEED) :

(a) While imposing traffic restrictions, the endeavour of the police always is to cause minimum inconvenience to the public.

(b) The Police Officials posted at traffic intersections for checking and diverting traffic and assisting the road users with proper diversions and directions are briefed to be polite and courteous in their behaviour.

(c) Wherever possible, the Delhi Police carve out separate routes for VVIPs keeping in view the security needs.

Hiring of militants by Pakistan from other countries

(a) whether Government are aware of a report appearing in the Hindustan Times dated the 9th April, 1993 that Pakistan is hiring militants and mercenaries from other countries to escalate terrorism in Punjab and Kashmir;

(b) if so, the steps taken by Government to curb that;

(c) whether Government have taken up the matter with that country to put down terrorism immediately; and

(d) if not, the reasons therefor ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI RAJESH PILOT) : (a) Yes, Sir.

(b) The Govt. have heightened the vigil on international border and paramilitary forces have been equipped with sophisticated border surveillance equipments to check infiltration of these mercenaries into India.

(c) and (d) The Govt. is making all the possible diplomatic efforts to effectively check Pak designs.
