Exports Licences to Pakistan issued by US

1077. MISS SAROJ KHAPARDE: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether it is a fact that the US Government have recently issued export licences totalling more than U.S. \$ 100 millions to Pakistan for buying spare parts for F-16 Fighter Planes and Cobra attack Helicopters;

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI R.L. BHATIA) : (a) and (b) Government have seen reports that since October, 1990 and upto mid-1992, U.S. State Department had issued export licences totalling more than U.S. \$ 100 million including spare parts for F-16 fighter planes and Cobra attack helicopters.

(c) Our concerns about any arms sales to Pakistan disproportionate to Pakistan's legitimate defence needs have been conveyed to all concerned including U.S. Government.

Government constantly monitor all developments having a bearing on India's security and take necessary measures to safeguard it.
