THE MINISTER OF STATE IN THE MINISTRY OF NON-CON-VENTIONAL ENERGY SOURCES WITH ADDITIONAL CHARGE OF THE MINISTER OF STATE IN THE MINISTRY OF AGRICUL-TURE (SHRIS, KRISHNA KUMAR): (a) Yes, Sir (b) The World Neem Conference was attended by about 450 delegates including 80 foreign delegates from 30 different countries. Indian delegates represented various govt. and non-govt. organisations, universities and the industries.

The Conference confirmed the value and the potential of neem and similar plants in sustainable agriculture, specially pest control, public and veterinary health and family planning.

- (c) The Conference recognised the role of neem as pesticide including mosquito control; as fertiliser and in medicine for public and animal health. In addition, the use of neem in soap and oil industry was also identified.
- (d) and (e) High priority to promote use of neem as one of the environmentally safe methods for pest control.

The Registration Committee established by the Government under the Insecticide Registration Act of 1968 has simplified the procedure to encourage commercialisation of the neem products for pest control for the benefit of the farmers.
