(b) and (c) Eighth Five Year Plan aims at bringing employment into a sharper focus in a medium term perspective with the goal of reducing unemployment to neglegible level within the next ten years.

The outlay for Rural Development in Eighth Plan has been stepped up considerably to Rs. 30,000 crores and major portion of this is proposed to be allocated to employment programmes. Jawahar Rozgar Yojana (JRY) and Integrated Rural Development Programmes (IRDP) ire the two major poverty alleviation and employment generation programmes. The primary objective of JRY is generation of additional gainful employment for the unemployed and under-employed persons in the rural areas. People below the poverty line constitute the target group. During the Eighth Five Year Plan, it is proposed to create a minimum of 1000 million mandays each year in the form of supplementary employment.

IRDP is a self-employment programme and its oyjective is to enable identified poor families to obtain incremental income for crossing the poverty line. Income generating assets are provided through a mix of subsidy and Bank credit. During the Eighth Five Year Plan, it is proposed to assist about 12.6 million families under IRDP. Preparation of credit plans, substantial increase in per family investment and proper provision of backward and forward linkages will be main thrust areas.
