Setting up of a New University in Nagaland

- *277. SHRI G. G. SWELL: Will the Minister of HUMAN RESOURCE DE-VELOPMENT be pleased to state :
- propose to (a) whether Government University in Nagaland; set up a new
- (b) whether it will be under Central or State auspices; and
- (c) if so, whether this would entail reorganisation of the North-Eastern Hill University?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (c) Government have enacted Legislation to set up a Central University in Nagaland.

Nagaland University Act has been assented to by the President.

Section 7 of the Act provides that (i) the jurisdiction of the University shall extend to the whole of the State of Nagaland and (ii) that on and from the any de-addiction centre of its own. commencement of the Act, all Colleges, Institutions, Schools and Departments affiliated to, or admitted to the privileges of, or maintained by, the North-Eastern Hill University shall stand affiliated to, or admitted to the privileges of, or maintained by, the University of Nagaland and (iii) that on and from the date of commencement of the Act, the North-Eastern Hill University shall cease to exercise its jurisdiction in the State of Nagaland.
