- (i) to recommend to the Group of Ministers/Cabinet that Rail Tel Corporation of India Limited (RCIL) should induct Joint Venture partner(s).
- (ii) RCIL should consider MTNL, VSNL and Railway Public Sector Undertakings (PSUs) for Joint Venture (JV) partner(s) for synergy, to start with.
- (iii) BSNL may also be kept in view for telecom business for mutual benefits.

These were examined by a Group of Ministers (GOM) and based on GOM's recommendations, the Cabinet decided to approve induction of Joint Venture partner(s) in RCIL keeping Railways equity as 51%. The Cabinet has also decided that initially, PSUs of Department of Telecom and PSUs of Ministry of Railways may be considered for inducting as Joint Venture partner(s).

- (c) The objectives of the proposed venture are:—
- (i) to expeditiously modernise Railways' train control, operational and safety systems and networks;
- (ii) to generate much needed revenues for implementing Railway's developmental projects, safety enhancement and asset replacement programmes;
- (iii) to create a nationwide broadband telecom and multimedia network to supplement national telecom infrastructure to spur growth of telecom, internet and IT-enabled value added services in all parts of the country specially rural, remote and backward areas; and
- (iv) to significantly contribute to realisation of goals and objectives of National Telecom Policy, 1999.

Accidents at unmanned railway crossings

(a) what is the number of fatal accidents at unmanned railway crossing in the country, Zone-wise during the last three years and the number of deaths in each case;

- (b) what is the number of unmanned railway crossings manned during the same period, against the target, stating the reasons for failure to fulfil the target; and
- (c) the details of programme, if any, formulated by Government to man the unmanned railway crossings in the country, stating the period by which the task is likely to be completed?

The manning of unmanned level crossings is to be sponsored by the State Government duly agreeing to bear their share of cost and providing funds therefor. Railway has however, decided to man 4449 unmanned level crossings on broad gauge routes from its own funds and work on 1810 unmanned level crossings has been sanctioned. In addition Hon'ble MPs are being approached to sponsor manning of unmanned level crossings from MPLADS funds. Railway has also decided to man one unmanned level crossing in consultation with Hon'ble MP at its own cost for each unmanned level crossing proposed for manning from MPLAD Scheme.
