'RE. PLIGHT OF PATIENTS IN VICTORIA HOSPITAL

SHRI TINDIVANAM G. VENKAT-RAMAN (Tamil Nadu)- I want to bring to the notice of this august House a serious matter reported in the *Indian Express* regarding a premier hospital in Karnataka, known as Victoria Hospital. The Intensive Care Unit was closed down two years back for want of anaesthetics. Even medicines, from life-saving drugs to those for ordinary illness or headache, are not available there at all. It is a pitiable case where this premier hos-

pital is struggling to survive and we do not know what will happen to it. The post-graduate students are made to perform Surgery with which they are not acquainted. Even anaesthesis is being given by junior doctors. This is the state of affairs of that hospital which is claimed to be a premier hospital—Victoria Hospital—and this sorry state of affairs needs to be rectified immediately.

I appeal to the Government to take some serious measures to pull up the machinery responsible for it. The patients are asked to buy medicines from outside, Even in emergency cases, the doctors have confessed, the patients have to wait for medicines to come from private medical stores.

This is a very serious situation and the Government should take note of it. I appeal to the Government to take some urgent steps in the matter so that the situation could be rectified.
