## Production of diesel cars

2943. SHRI K. RAMA MOHANA RAO: Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

- (a) the total number of diesel cars produced in the country, segmentwise;
- (b) the total annual consumption of diesel by these diesel vehicles, segment-wise; and
- (c) the total amount of subsidy that Government have given annually to the above segment diesel cars during the last five years?

THE MINISTER OF STATE IN THE MINISTRY OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (DR. VALLABH BHAIRAMJI BHAI KATHIRIA): (a) No separate data regarding production of passenger cars, fuel wise is maintained. A manufacturer has full freedom in the production of diesel or petrol driven cars.

- (b) Separate record for consumption of diesel by diesel driven passenger cars is not maintained.
  - (c) There is no subsidy for diesel cars.

THE MINISTER OF STATE IN THE MINISTRY OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (DR. VALLABH BHAI RAMJI BHAI KATHIRIA): (a) and (b) Pursuant to the Reservation in jobs to persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, all the Central PSEs have been advised through their administrative Ministries to comply with the provisions of the Act wherein

reservation of not less than 3% of jobs has been provided for persons with disabilities. Regarding employment of women in PSEs, the number of women employees in the PSEs for the years 1997-98,1998-99, 1999-2000 was 1,11,706, 1,07,077 and 10,4,282 respectively.

(c) As regards details relating to employment of women and Physically Handicapped persons, all the below Board level appointments come within the purview of the managements of respective PSEs and such details are not centrally maintained.

## **Change in Existing VRS**

- (b) As per available information 42824 employees have availed themselves of the existing scheme during 2000-2001.
