come back to the House. The recommendations and the action taken may be placed on the Table of House. Apart *from* the record of the House, they are there, but I shall certainly see which of them have been accepted, which of them a;re under consideration.

THE DEPUTY CHAIRMAN: You see. . . (*Interruptions*). . . Order.

SHRI TINDIVANAM O. VENKA-TRAMAN (Tamil Nadu): Madam, one point only. The Verma Commission Report has been placed on the Table of the House but we have not got a copy of *it*. We have applied tor it but nobody has responded to that. I am very sorry...

THE DEPUTY CHAIRMAN: But the copies are supplied. Only then the House will. . . (*Interruptions*), . .

SHRI TINDIVANAM G. VENKA-TRAMAN: Please supply us a copy.

THE DEPUTY CHAIRMAN: I will find out.-.

SHRI TINDIVANAM G. VENKA TRAMAN: This is a most important thing.

THE DEPUTY CHAIRMAN: I will find out. I know that it was tabled.. (*Interruptions*) Now everybody, all the Members, should get it. All right. It is a very serious matter. Rajiv Gandhi's assassination and also what is happening in the country today, all these bomb blasts in various part's of the country there could be a possibility that there is some nexus among them and to find Out what the truth is the Government should take necessary action. Now, that is all. . . (*Interruptions*). . .

SHRIMATI JAYANTHI NATARAJAN (Tamil Nadu): Madam, I want to speak on another issud

SHRI SUKOMAL SEN (West Bengal): Madam, I want to know... THE DEPUTY CHAIRMAN; Other issues are there. Once my observation is made. please take your seat. . . (*Interruption*)

... Not on this . . . (Interruption) ... Not an this. Not this. . . (*Interruption*). ... Not on this issue. It is one and the same thing.

SHRI SUKOMAL SEN: Madam, the Home Minister should tell us whetner they have contacted the U.S. Government and what the reaction of the VS. Gov ernment is.

THE DEPUTY CHAIRMAN: That will come together when the Calcutta report will be given. You can then ask * the Government because there is no point in raising it now. Nobody can answe just now. Please sit down. (In*terruptions*)...

SHRIMATI JAYANTHI NATARAJAN: Madam. I want to raise another issue.

THE DEPUTY CHAIRMAN: I will allow you.

DR. JINENDRA KUMAR JAIN Madam, please allow me to raise an issue.

THE DEPUTY CHAIRMAN: No. I

said no. You don't di»turb.

RE. MOTION OF PRIVILEGE AGAINS DOORDARSHAN

श्रीमती कमला सिन्हाः (बिहार) मैडम, मैं प्रिविलेज का मोशन उठाना चाहती हूं। एक सदस्य होने के नाते हम लोगों के कुछ प्रिविलेजेज हैं। कल मैंने यहां एक विषय पर सदन की बैठक में भाग लिया था त्रौर रात को जब पालियामेंट न्यूज या रहा थी तो उस पालियामेंट न्यूज में हिंदी में दो दफा मेरा नाम लिया गया। एक दफा तो कहा गया कमला सिम्हा, अत्तर दला दूसरी दफा कहा गया, कमता सिम्हा, जनता पार्टी ग्रौर ग्रंग्रेजी में अत्र न्यू र ग्राई तो उसमें कहा गया कि कमला सिन्हा, कांग्रेस (ग्राई) मैंडम, इससे कनफूजन होता है (ग्यवधान) यह हंसी की वात नहीं है। यह बहुत सीरियस बात है। मैं दल-खदलू नहीं हूं। I am not a defector.

मैडम, दूरदर्शन के उत्पर मेरा यह प्रिविलेश मोशन है। दूरदर्शन को कहा जाए कि अपर इस तरह की बात होगी तो-I will give a privilege notice.

यह बहुत ही गलत बात है।

THE DEPUTY CHAIRMAN: If you are moving a motion of privilege you can give it to the Secretariat and then we will put it before the Chairman and his decision would be final.

SHRIMATI KAMLA SINHA: O.K.. Madam.

(Interruptions).

SHRIMATI TINDIVANAM G. VEN-KATRAMAN (Tamil Nadu): Madam. I also want to raise an issue regarding Doordarshan. They are not able to correctly pronounce even the names of the parties. 'DMK' they are not able to pronounce.. They say 'Dumka Party'. They should know low to prenounce the names.

भी मोहम्बद सलीम : (पश्चिमी बंगाल) **मैकन,** म्राज सुबह पूरे देश के लोग जब इस बात का इंतजार कर रहे थे कि **दूरदर्शन के न्युज ब्**लेटिन में क्या ग्रातः हे क्योंकि कलकता में बम ब्लास्ट हुआ था। महोदया, यहां हम कहते हैं कि हम विदेशी टेलीविजन से कम्पीट करेंगे, हमारे **यहां इतना टैक्नोलॉ**जिकल डवलपमेंट हुम्रा है । फिर जब ग्रंग्रेजी न्युज ब्लेटिन 8.15 भर शुरु होता हैं तो उसमें बताया गया कि कलकत्ता में मिड-नाइट को धम ब्लास्ट हुआ। मैडम, अख-बार में लोग खबर पढ़ चुके थे ग्रौर जानना चाइते थे कि डिटेल्स क्या हैं? मौर. इधर दूरदर्शन पर कोई विजुग्रल नहीं है, जबकि कलकत्ता से दिल्ली हमारा **सेटलाइट क**नेक्शन है ग्रीर उसके बाद

भी विज्याल प्राप्त नहीं होता। खबर के आखिर में पहुंचते हैं तब कहते हैं कि अभी-ग्रभी इमें विजयल मिला और उसको दिखात हैं जो कि बहुत ही टैक्तीकली खराब था, लेकिन विज्यल दिखाए । यह पहली बार ऐसा नहीं है। जबकि सी.एन.एन. ने पूरे देश में विखा दिया, पूरे विण्व में दिखा दिया एक घंटें कि अधिर स्रोर हमारे यहां छह वर्ट ग्राठ घंटे के बाद भी विजन्नल प्राप्त नहीं होता है। हम लाखों, करीड़ों रुपया खेचे करते हैं, इतना स्टाफ है. यह सब माखिर किस लिए ें पूरे देश को इंफोर-मेशन देनी पड़ेगी। संत्री को सही समय गर रिगोर्ट नहीं मिलती, टेसीविजन को सही समय पर विज्यल नहीं मिलता। ग्राखिर, हम किस प्रंधेरे में रहते हैं, किस युग में रहते हैं?

SHRI JOHN F. FERNANDES (Goa): Madam

THE DEPUTY CHAIRMAN-. What is that? We are not discussing Doordarshan *(interruptions).*

SHRI JOHN F. FERNANDES: Madam, I made enquiries with the Doordarshan staff and they said that they were not responsible for the mistakes because the news was reported to them by private correspondents. So, I would request the Minister to see that their own correspondents are appointed here and new_s should not be taken from private correspondents.

THE DEPUTY CHAIRMAN: I will discuss, the matter with the Minister and we will see that these mistakes do not labour I will ask the Secretariat to sup-the list of the Members of Parliament with their party affiliations to those people who cover the news so that they have the list which they don't have already. They should llave that paper to refer to. That matter is cover now. (*In. terruptions*)...

SHRI TINDIVANAM G. VENKAT-RAMAN: Apart from that, one more point is-...(*Interruptions*)...

THE DEPUTY CHAIRMAN: Shrimati Jayanthi Natarajan.

SHRIMATI JAYANTHI NATARA-JAN: Madam, the entire House has been agitated over the serious bomb blasts in bombay and Calcutta. (Interruptions).

श्रीमती कमला सिन्हाः मंडम, जो मेरा नाम इस तरह से. गलत तरीके से, कहा कि कांग्रेस-म्राई ग्रौर जनता पार्टी, इसके बारे में आज तो कहिए कि वह खेद प्रकट करें, आज जब न्यूज पढेंगे रात को उसमें खेद प्रकट करें। यह तो झाप कहिए ।

THE DEPUTY CHAIRMAN: I will find out.

RE. DEMAND FOR BAN ON BJP RALLY AT MADRAS

SHRIMATI JAYANTHI NATARAJAN (Tamil Nadu): Madam: the entire House has been agitated over the very serious situation prevailing in the country. (Interruptions) . .

THE DEPUTY CHAIRMAN: Order, please.

SHRIMATI JAYANTHI NATARAJAN; Madam, with all the bomb blasts a serious situation is prevailing in the country and the Members have already spoken about the threat to Delhi. There may be a threat to Delhi. The next city is possibly Madras.. We don't know. So far, there is no threat. Madras is a major metropolitan sity. There is going to be a possible threat to Madras also. Obviously the target of all these people is crowded areas where people gather. Unfortut-nately further attempt has been made to communalise the situation so that there will be riots in the country and we have noted the connection between the Bombay riots avid the later bomb blasts'. In that view of the matter the reports appearing in the morning papers that Mr. Advani will be addressing a major public meeting in Madras city cause grave concern to the people of Madras city. (Interruptions).

SHRI TINDIVANAM G. VENKAT-RAMAN (Tamil Nadu): The meeting should be banned, (Interruptions) ...

SHRI MISA R. GANESAN (Tamil Nadu)-The BJP (should be banned. (Interruptions) ...

SHRI TINDIVANAM G. VENKAT-RAMAN: We must take precautionary measures. What she says is correct. (Interruptions). . .It is perfectly correct. (Interruptions) ...

SHRIMATI JAYANTHI NATARA. JAN: It is a serious matter, Madam. If the BJP is allowed to hold a public meet ing by the State Government at the Ma rina grounds-we understand that-the State Government is helping them gather a huge crowd there-this will be a target \Ve hear reports that the State Govern ment is asking truck operators to bring large crowds. We hear that the poor people of Tamil Nadu, the people of Madras city, will be in great dager and that this will be a prime target. I there fore, feel that it will not be possible to maintain. ... (Interruptions)...I think the Home Minister has taken action. The Home Minister has already written to the Chief Minister of Tamil Nadu. ... (Interruptions).
