STATEMENT BY MINISTER

Bomb explosion in Calcutta on 16 March 1993

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI RAJESH PILOT): Madam Chairperson, I wish to share the concern of the House on the tragic incident of the explosion that-took place

[Shri Rajesh Pilot] in Calcutta on 16.3.1993. Immediate ly on learning about the unfortunate incident, I rushed to Calcutta early in the morning yesterday to take stock of the situation with a view to assist the State Government in their efforts. Also, I was keen to come back before the House was adjourned so that I could explain the situation to the House personally. But, unfortunately, the aircraft engine had some problem and we had to make an emergency landing at Lucknow. Mr. Somnath Chatterjee, Member of Parliament, and my colleague, Mr. Ajit Panja; were with me. And it delayed us by one and a half hours and I could land here only at 8.30 or 9 o'clock.

DR. YELAMANCHILI SIVAJI (Andhra Pradesh); Who was the pilot in the aircraft?

THE DEPUTY CHAIRMAN: Not Mr. Rajesh Pilot.

SHRI RAJESH PILOT: The learned Members of the House would be by now aware of most of the details However for placing the facts on record. I would like to give the available details.

On 16th March_ 1993 around mid night (at 11.58 PM), a big explosion shop-cum--residential occurred at 266 and 267 Bowbazar premises at Street at Calcutta. One three. storied an,d one two storied building were demolished in this explosion. Damage to walls; doors and windows of four adjoining houses was caused resulting in the death of 62 persons and injuries to 92 persons. Of these 45 have been hospitalised and 47 have been discharged after first_aia*r Out of 45 hospitalised persons; condition of 16 persons is serious. I visited the hospital along with the Chief Minister of West Bengal and met the injured persons. Later: I visited the site where this incident had taken place. I also held detailed consultations with the Chief Minister of West Bengal; senior Government and police officials and assured full support of Government of India as may be required.

Rescue operations are still continuing with the help of the police; Central Para-Military Forces and Army; fire-fighting units and civil defence personnel.

Special efforts are being made to provide proper medical care to the injured persons. Relief is being provided to the people who have been evacuated from the area and other affected persons.

A team of experts on the Bombay pattern; which is investigating at Bombay; is being sent and various agencies and discipline were sent to Calcutta to ascertain the cause of explosion. In addition to the above, experts of agencies located in Calcutta are also assisting in the investigations.

Additional para-military forces are also being made available to the State Government.

Two persons have been arrested so far. Investigation is in progress.

I can understand the anxiety of the House to know whether there is a linkage explosions that look place in between the Bombay and In Calcutta. are still in progress and every investigations possible aspect is being looked into, and, as such; it is not possible at this stage to give any definite conclusion on this. The impression; however; which I got on the basis of my discussions with the State Government 'officials and the injured people that nothing appears to have come to notice so far establishing linkage between the two incidents as yet. Nothing; however, can be ruled out this stage. Why I mentioned this here is because I have visited both the sites. I had gone to Bombay and I have seen these explosions and I have seen how strong devices were used. The

bomb blast was around 200 yards. The other buildings were equally affected and their doors and walls were damaged. But that was not the case here. When I was talking to the people, they were saying:

'सेल्फर का महंक क्राया था

Some people said, they say a lighting sort of spark. Seeing the damage in the next building, only one room was affected. This is my personal view after visiting both the sites that it is not on that line. But since the investigation is on, I don't rule out anything till we reach the right clue.

State Governments all over the country have been asked to maintain maximum vigil and alert and to step up security measures to the fullest. They have been advised to establish control Rooms right upto district levels for round-the-Clock monitoring.

On return from Calcutta which was delayed due to technical snag, I visited two States viz., Madhya Pradesh and Gujarat to review the situation with the State Government officials. I propose to visit other States in the next few days, for ensuring better interaction and fullest cooperation from the Centre to the States to face this challenge of disruptive forces. Thank you.

THE DEPUTY CHAIRMAN: Now, I adjourn the House for lunch till 2.30 p.m. We will take up the clarification when we assemble at 2.30 p.m.

The House then adjourned for lunch at thirty-four minutes past one of the clock.

The report which has appeared in the press in Bombay is. .. (Interruptions) ...

THE VICE-CHAIRMAN (SHRI MD. SALIM): You have aleady raised it. The moment we have information from the Ministry of Parliamentary Affairs, we will let you know.

SHRI YASHWANT SINHA (Bihar) Mr. VICE-CHAIRMAN, the Government should respond... (Interruptions) . ..

THE VICE-CHAIRMAN (SHRI MD. SALIM); Please, one minute.

SHRI YASHWANT SINHA: Sir, Mr. Jagesh Desai has been raising it. The House has been agitated about it. The Government should respond.

THE VICE-CHAIRMAN (SHRI MD. SALIM): That is an important issue, of course.

SHRI VITHALRAO MADHAVRAO JADHAV (Maharashtra): Mr. Vice-Chairman, after the Bhopal tragedy, do we want the same kind of crisis to happen in Bombay city? Bombay is already burning because

[Shri Vithalrao Madhaurao Jadav] of the bomb blasts and so many other things that had happened there. If the gas leakage is there and if the industries behave in this fashion the poor people will loss their lives. It is very essential that the Home Minister should come forward. The Home Minister has already assured that he would come. . . (interruptions) .. I want the hon. Minister to make a statement. (Interruptions)...

SHRI JOHN F. **FERNANDES** (Goa); Mr. Vice-Chairman, Sir, I have to commend the hon. Minister for coming to the House... {Interruptions) ...

THE VICE-CHAIRMAN (SHRI MD. SALIM): Mr. Jagesh Desai, this is also an important issue. This id clarification on the statement made by the Minister on the Calcutta bomb blast. (interruptions)... Let the clarifications be taken up. The moment the Government is ready with a statement, we will announce it. There is no problem.

SHRI JOHN. F. FERNANDES: Mr. Vice-Chairman, I was saying that X have to compliment the hon. Minister for giving firsthand information to this House because the hon. Minister himself has visited the place. Still there are many doubts .I hope the hon. Minister will clarify them. It was mentioned that there was no similarity between the explosions which took place in Bombay and Calcutta. It is presumed that the explo-son in Bombay was caused by RDX substance which was imported to this country. The explosion in Calcutta was caused by some crude bomb. The hon. Minister said that they had not established any link between the two explosions. The Minister has mention ed that two buildings situated in plots 226 and 227 had come down. The Minister has also mentioned that two people had been arrested. May I know from the hon. Minister whether these people are the owners of the plots or land. I would like to know whether there is any conspiracy, taking advantage of the bad situation in the country, by these houseowners to evict the tenants and take free possession of these buildings.
