## RE. IMPOSITION OF HINDI ON PEO. PIE OF TAMIL NADU BY DOORDARSHAN

SHRI C. SWAMINATHAN: Madam, I want to raise a very serious matter affecting the sentiments of the people of Tamil Nadu. The Tamil broadcasting time on the Doordarshan has been reduced from 9.00 P.M. to 8.45 P.M

[The Viee-Chairman (Shrimati Sushma. Swaraj) in the Chair.]

Madam previously the T.imil news transmitted between 8.40 P.M. and. 9.00 P.M. But now what have they done? They have reduced Now they are commencing it at 8.30 P.M. and concluding to 8.45 P.M. The argument that has been given by the Direc'or of Doordarshan is that the Tamil TV viewing timing formerly started at 5 o'clock and ended at 9 o' clock. I do not know whether this was his argument or the argument given by the Government. As a matter of fact, he has been broadcasting now from 5.30 P.M. to 8.45 P.M. and in that sense he has increased the time. But what we have been agitating is that the original time was the prime time for the people of Tamil Nadu. As you know, many of the people of Tamil Nadu can neither speak nor write Hindi They do not know Hindi. So the people have been seeing the programme after roming from theeir offices. After 6 or 7 o'clock they start viewing to the Dcordarsha<sub>n</sub> programme. They

were very happy with that, t went on up to 9 o'clock. After 9 o'clock, as far as the State of Tamil Nadu is concerned there has been no T.V. viewing by the people. So it is agitating the mind of the people that the Government of India has been indirectly imposing Hindi upon the people of Tamil Nadu. In this connection the Tamil Nadu Assembly had also passed a resolution on the 10th January request, ing old timings I do not know whether the Congress Member, want the -rnposi-tion of Hindi in Timil Nadu. As request by all the parties there the original T.V. viewing timing should be restored. I hope the Congress party will also accept the proposition that the original timing has to be restored which has been pressed by the Tamil Nadu Assembly.

Madam, you know the sentiments of the people of Tamil Nadu. Iney do not want imposition of Hindi. Similar resolutions on the two-language formula had been passed during the time of Anna and also during the period of MGR. We personally feel that Doordarshan is trying to impose Hindi on the people of Tamil .Nadu.

I wish to stress on this occasion two important things. One is that the Government of India should restore the old timings. The other i<sub>s</sub> that the news should be from 8.40 P.M. to 9.00 P.M. The TV viewing time should be from 5.00 P.M. to 9.00 P.M. I think it is a reasonable request. I do not know why they should resist it

Madam, in the year 1965 there was an anti-Hindi agitation. According to Nehru's assurance, English should be an associate language along with Hmdi. We wish that that the assurance by Pandit Tawaharlal Nehru, in the present context, should also be made as one of the Constitutional provisions.

Madam, I hope that the Government will give an assurance on this matter, Thank you...(Interruptions'\* ...

THE VICE-CHAIRMAN (SHRIMATI SUSHMA SWARAJ): Mr. Muthu Mani, you can only associate ourself

your colleague. All of you cannot speak.. . (Interruptions) ...

SHRI S. MUTHU MANI; We oppose imposition of Hindi on Tamils... (In-terruptions)...

SHRI SUBRAMANIAN SWAMY: Madam, are you calling me on this issue or another issue?

THE VICE-CHAIRMAN (SHRIMATI IAYANTHI -NATARAJAN); Do you want to say something on this issue?

SHRI SUBRAMANIAN SWAMY: On ihis issue, I do not want to say anything except to ask what their new ally, BJP, wants to say about this. I want to speak on some other issue.

THE VICE-CHAIRMAN (SHRIMATI IAYANTHI NATARAJAN): Okay, I win allow yon afterwards.

SHRIMATI JAYANTHI NATARA-JAN (Tamil Nadu): Madam, on this issue I want to speak. First of all, I would like to say that the hon. Minister has already given an assurance that there will be no imposition of Hindi on the people of Tamil Nadu. We are al! aware of it as is Mr. Swaminathan.

Madam, I also support the demand that the prime time of the Tamil trans mission should not be reduced even though the Tamil transmission has been increased by fifteen minutes. I also sup port the demand that at the prime time !here should be transmission of the But unfortunately regional language. this matter is being politicised in a wrong way in the State. I feel that this has created a great deal of difficulty because of the kind of confron-tationist stand which has been adopted by certain people. SHRIMATI JAYANTHI NATARA-JAN: i am finishing now. My only point is-I say this on behalf of my party and on behalf of the Congress party in Tamil Nadu-that we are totally of the view that there should be no imposition of Hindi. We have also fought for it in this House. I plead with all the Members, with other Members and with other parties, not to encourage divisiye forces. Because of this, a very bad feeling has been created in the State. After the Congress Members were avicted from the Assembly on this ground, after the Congress Members in the Assembly were not allowed to speak, there was a massive bomb blast in the Hindi prachar Sabha. This bomb culture should not be allowed to grow in Tamil Nadu. Therefore, I also ask the hon Minister to give us an assurance.

THE VICE-CHAIRMAN (SHRIMATI SUSHMA SWARAJ): Mr. Maran. (In terruption) I will identify you, Mr. Subramanian Swamy, after this is over.

SHRI MURASOLI MARAN (Tamil Nadu): Madam Vice-Chairman, I entirely agree with Thirumathi Jayanthi Natara-jan that we should not encourage divisive forces. But, you are creating the divisive forces. Who asked you to change the status quo regarding the timing of the Hindi nationa] broadcast? A feeling has been created that 'national' means 'Hindi' and National'. This is not good. mean<sub>s</sub> When I put a supplementary question to the hcta. Minister of Information Broadcasting, he assured us that he would respect the sentiments of the people of Tamil Nadu. Yes, Madam, I thank the hon. Minister. But how many assurances have we got? We have Pandit Nehru's assurance on this language policy; we have Lai Bahadur assurance to the non-Hindi speaking people; we have Indiraji's surance to the non-Hindi speaking people; we have got Rajiv Gandhi's assurance to the non-Hindi-speaking people. Now, this is Singh Deo's assurance. We do not want to believe in assurances any more. It is. after all, a small admuuV trative ordeir. Therefore, I request the hon. Minister, who is here, to respond, Let. him not prestige, This is a time when the country is passing through a crisis. You are seeking tb\ support and cooperation of all the parties. All the people must unite together to fight the communal forces. In this context, why are you stirring up a hornet's nest? I would appeal to the hon. Minis'er to be rational. Let him not stand on false prestige. Let him come out and straightaway say, because he is in independent charge of the I & B Ministry, that the status quA ante will be restored. Otherwise, an agita tion will come up: the entire Tamil Nadu will go up in flames. (Irterreption)

SHRT G. SWAMINATHAN: Madam.-

THE VICE-CHAIRMAN (SHRIMATI SUSHMA SWARAT): Mr. Swaminathan, yon havo already said enough.

SHRI MURASOLI MARAN: Madaitt. I agree with Thirumathi Jayanthi Nataraj an that there cannot be any imposition of Hindi because they have learnt a bitter lesson in 1965. Now, that is why they are indirectly imposing Hindi through the Doordarshan. This is on aggression by air. Therefore, I would once again request the hon. Minister to be fair to respect the sentiments of the people of Tamil Nadu. (Interruption).

THE VICE-CHAIRMAN (SHRIMATI SUSHMA SWARAJ; One minute, Mr. Swaminathan. I will ask the hon Minister to react. Would the Minister lite to react to him?

SHRI G. SWAMINATHAN: The Tamil Nadu Government, a majority Government there, has passed a resolution in the Assembly i would request the hon. Minister to give an assurance because the Chief Minister has already writen a letter to the hon. Prime Minister. There have been talks on behalf of the Government of Tamil Nadu with the Government of India. A lot of correspondence has been sent and a lot of discussion has taken place. This is no' the first time that we are talking about it here. This is matter which has been taken up by the Government of Tamil Nadu. On behalf of the Government of Tamil Nadu and the! AIADMK, I request th^ hon. Minister for an assurance in this House.

SHRI V. NARAYANASAMY (Pondicherry): Madam, I rise to support the matfer raised by Shri Swaminafhanji.

SHRI G. SWAMINATHAN: Madam, I am 'G. Swaminathan' and not 'Swami-than. G.'

SHRI V. NARAYANA SAMY; Sometimes, we add the initials behind the name

THE VICE-CHAIRMAN (SHRIMATI SUSHMA SWARAJ): Only in directories.

SHRI S. S. AHLUWALIA: He is not interested to take a respectable word in Hindi. THE VICE-CHAIRMAN (SHRIMATI SUSHMA SWARAJ): Only in telephone directories, we do like that, not in Parliament.

SHRI SUBRAMANIAN SWAMY: As far as you do not call him •Swamyji', it is okay. In the prime time we had the

Tamil news bulletin which was well received by the people of Tamil Nadu and also by the people in the souther, region. This time was minimised and the Hindi news bulletin was imposed from 8.45 p.m. to 9.00 p.m. Though, they reduced the 'ime from twenty minutes to fifteen minutes the people of Tamil Nadu have to see this programme right from January 1st. I would like to know from die hon. Minister who made such an arran-gfment when there were clear instructions from the Information and Broadcasting Ministry that regional news bulletins will be there and thereafter the English news bulletin will b© there. The timings were changed from 9.35 p.m. to 9.45 p.m. Madam, the point is very simple. Time and again, the people from Tamil Nadu and other regions, where regional languages are being spoken, have been requesting the Government of India that there should not be imposition of Hindi either directly or indirectly. But we find that not only the Ministry of Home Affairs... (Interruptions) I am expressing the sentiments of the people of my State.

SHRI SUBRAMANIAN SWAMY: But he is hot from Tamil Nadu. He is from Pondicherry.

THE VICE-CHAIRMAN (SHRIMATI SUSHMA SWARAJ): Don'\* interrupt.

SHRI V. NARAYANASAMY: Though a clear-cut policy had been announced by Pandit Jawaharlal Nehru, Shrimati Indira Gandhi and Shri Rajiv Gandhi, right from the Home Ministry to the Ministry of Information and Broadcasting, they are trying to impose Hindi by one way or the other

THE VICE-CHAIRMAN (SHRIMATI SUSHMA SWARAJ): Let the Minister react.

SHRI V. NARAYANASAMY: Hov can the Minister react without hearing me? This has hurt the sentiments Of the people. There cannot be any objection about those people who would like *to* read Hindi voluntarily. But the Government of India and the Minis-

try of Information and Broadcasting should not impose Hindi by visuals, by speeches and by discussions. After 9 o'clock, the people in Tamil Nadu are not viewing TV at all. They have to do like that because except the English bulletin, the entire programme is in Hindi. Therefore, the Information and Broadcasting Ministry should specifically see that during the Prime time, after 9 o'clock, right from 5.30 p.m. to 9.00 p.m., regional programmes should be given complete freedom. We do not have any objection to whatever programmes they bring in Hindi or in any language they want. But I am telling the sentiments of the people. I hope, the hon. Minister will respect the sentiments of the people of the southern regions of the country and win accept our demand.

SHRI SUBRAMANIAN SWAMY: Madam, before the Minister speaks; I have a suggestion.

THE VICE-CHAIRMAN (SHRIMATI SUSHMA SWARAJ): What suggestion do you have? When I asked you to speak on the issue, you said noting,

SHRI SUBRAMANIAN SWAMY: I have only a one-line suggestion that there should be one all 100 per cent Tamil channel for Tamil Nadu so that this problem does not arise frequently.

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI K. P. SINGH DEO): Madam Vice-Chairman, art the very outset. I must say that I agree with the sentiments expressed is this House by G. Swaminathan, Murasoli Maran, Narayanasamy, Shrimati Jayanthi Natara-jan and Subramanian Swamy. This decision to change the timings was taken on the 1st January 1993. It was based or. the recommendations of the Committee which had been set up because various views had been expressed earlier on that. We must meet the chaflenges from the sky and from the cables and I must say that we have an open mind. A lot of misgivings and a lot of apprehensions have appeared in the press a\* well as in Parliment- I can assure you that we will go into the depth of •it and we will come back to the House

[Shri K. P. Singh Deol

with full information. At the *moment, I* do not have the information. One Committee had gone into it. I do not want to take a unilateral decision on. the spur of the moment and create more problems. (*Interruptions*) I would like to respect the sentiments of not only Tamil Nadu and Pondicherry, but as I said in the Question Hour, I would like to reiterate, of all parts of the country. We would like to give respect to the sentiments *at* the people of all regions of the country and I will come back to the House with full information.

SHRI SUBRAMANIAN SWAMY (Uttar Pradesh): Madam Vice-Chair-man, the President in his Address referred to the crisis in the Country. It is his words that there is a crisis in the Country in which all of us should get together to see that communal propaganda is not disseminated against. Communal propaganda meetings are now being banned in the country but we find that in one part of India this communal propaganda is going on in full speed and permission is being given by the State Government to hold such meetings. Recently in Coimbatore Hindu Munnani held a meeting in which a most vicious propaganda was let loose and the Rashtriya Swayam Sewak Sangh's top leaders attended and addressed the meeting. Now I would like to know whether the Tamil Nadu Government respects this sentiment of the nit'on that communal meetings should not be allowed and if the Government of Madhya Pradesh can be dismissed for allowing communal propaganda, I don't understand why the Tamil Nadu Government should not be similarly dismissed... (Interruptions)...

THE VICE-CHAIRMAN (SHRIMATI SUSHMA SWARAJ); Do you want to associate yourself, Mr. Maran?

SHRI MURASOLI MARAN (Tamil Nadu): No, no; in a different way... (Interruptions)...

SHRI G. SWAMINATHAN (Tamil Nadu); This is not a banned organisa tion. You don't know. . . . (Interruptions) . .

SHRI MURASOLI MARAN: Madam Vice-Chairman, I am not the one to curb the civil liberty activities. I am not for that. I am not for banning any procession, either in Delhi or in Coimbatore because I believe in -upholding civil liberties but what I want to point out is the doubly standards adopted by the Government of India. You are ban ning a procession here, you are ban ning a rally here but in a State where you are an ally, so-called ally-I don't know whether allied any more or notyour State Government is permitting the Hindu Munnani, that means Hindu front, another front organisation of R.S.S. to hold the meeting. This is a double standard... (.Interruptions)... I am not finding fault with anybody. 1 would like to know the reaction of the Home Minister. What does the Home Minister want to say? iVhy should be adopt double standards? Why is he ban ning a rally here? You are allowing a rally at Coimbatore. I want to point, out the double standards adopted by the Government India... (Interrupof tions)...

SHRIMATI JAYANTHI MATAR IAN; Madam, on this issue I want to make a submission. - . (interruptions) . . .

SHRI G. SWAMINATHAN: Madam, Tamil Nadu Government is a democratic Government. In Tamil Nadu there is democracy and Hindu Munnani is not a banned organisation and we are not taking action... (Interruptions)...

THE VICE-CHAIRMAN (SHRIMATI SUSHMA SWARAJ): On that point you have already spoken, Mr. Swaminathon. I haye given her permission to speak.

SHRIMATI JAYANTHI NATARA-IAN: Madam, on this issue... (*Interruptions*)...

SHRI G. SWAMINATHAN: How can we ban a front organisation. There is no necessity for it.

THE VICE-CHAIRMAN (SHRIMATI SUSHMA SWARAJ); Your views have been recorded. Now please sit down... (Interruptions). . .

SHRI G. SWAMINATHAN: Whenever ther $_{\rm e}$  is a democracy, allow the democracy to function.

SHRIMATI JAYANTHI NATARA-JAN.-Madam, I am surprised I am sure, Mr. Swaminathan is not aware of what happened at that rally. Very bad communal sentiments were voiced at that rally. It is a shame that Mr. Swaminathan is trying to support... (Interruptions) . . .Madam, only one word. I remarked that after this meeting.. . (Interruptions) . ..

SHRI G. SWAMINATHAN; I am not aware, Madam... (*Interruptions*)... If anything untoward happens, the Government of Tamil Nadu will take suitable action in the matter.. (*Interruptions*)...

SHRIMATI JAYANTHI NATARA-JAN; Just one sentence, Madam. They were not allowing me to speek. I call upon the Home Minister of India to ban Hindu Munnani immediately. Madam, Hindu Mannani should be banned.
