1134. SHRI PARMESHWAR KUMAR AGARWALLA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether it is a fact that 13 oil and gas fields were discovered during 1992-93;
 - (b) if so, the details thereof;
 - (c) the estimated reserves of the fields;
- (d) by when production would start from these gas fields; and
- (e) whether India would attain selfsufficiency after the production starts from the new gas fields?

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (CAPT. SATISH SHARMA): (a) and (b) During 1992-93 (April to December, 1992) 13 new hydrocarbon discoveries have been made by ONGC. These include; Gulf-A, Gulf-D and Khambel in Cambay Basin, B-59, B-127, C-23, GK-22, C and B-45 in Bombay offshore, Nandigama, Vijaypuram and GS-29 in Krishna-Godavari Basin and Vadatteru and Attikadal in Cauveri Basin.

(c) to (e) Estimated reserves, production potential and time frame of development of each discovery can be determined only after delineation and appraisal drilling.
