- (b) The manufacturers have been asked to put the waring "the drug has potential for abuse and should be sold and used under strict medical supervision" in red colour on the label and carton of the formulation.
- (c) Manufacturers have also been asked to consider the marketing of a combination of Buprenorphine with Nalaxone to reduce the abuse potentiality of Buprenorphine.

(d) DCG(I) has issued suitable instructions to the State Licensing Authorities requesting them to issue instructions to the Inspectorate staff to prevent the easy availability of the drug Buprenorphine through retail outlets and also to ensure that the drug marketed under different brand names is supplied only against the prescription of a registered medical practitioner only.

Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

(a) whether Railways have put a hold on release of wagon orders to public sector wagon industries pending enquiry into alleged use of non-specified steel in wagon manufacture;

(b) if so, whether Braithwaite, Bum Standard, Jessop and other PSUs are facing severe crisis because of this delay in order;

(c) the action taken by Government to ensure quality as well as timely placement of order; and

(d) the present order position?

THE MINISTER OF STATE IN THE MINISTRY OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (DR. VALLABH BHAIRAMJI BHAIKATHIRIA): (a) Railways have been unable to place wagon orders owing to outstanding orders and pending vigilance checks relating to use of mild steel in place of specified corten steel being supplied by Railways to the wagon manufacturing units.

(b)Yes, Sir.

(c) Ministry of Railways has advised the Research Design and Standard Organisation (RDSO), Lucknow, the agency responsible for ensuring quality,

to take additional measures in this respect and incorporate the same in quality Assurance Programme.

With regard to time placement of orders, the matter has been pursued with the Ministry of Railways at different levels.
