1098. SHRI SUNDER SINGH BHANDARI: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that Agarwood smugglers operating from Hojai (Assam) engineered the communal violence of December, 1992 in the area;
- (b) whether it is also a fact that there are a number of agarwood plantations in the whole of North Eastern region of the country;
- (c) whether it is a fact this trade is entirely check up by in migrant Muslims; and
- (d) whether Government are aware that these agar shanks formed several Islamic suicide squads and arms were procured from Bangladesh?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P.M. SAYEED): (a) to (c) It is a fact that the Agarwood trade is by and large controlled by Muslims, all of them are not migrant Muslims. There is, however, no information about Agarwood smugglers operating in Hojai (Assam) having engineered communal violence in December, 1992.

(d) There is no such information.
