

### Guidelines Regarding Hoisting of National Flag on Republic Day

1069. SHRI O. RAJAGOPAL: Will the Minister of HOME AFFAIRS be pleased to state:

(a) Whether any Guidelines have been issued in regard to the Hoisting of National Flag on Republic day/ Independence Day; if so, what are the details in this regard; and

(b) whether it is a fact that Police obstructed and prevented the Bhartiya Janata Party Workers in hoisting the National Flag on 26th January, 1993 at Vaoakkanchery in Palghat District of Kerala, if so, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P.M. SAYEED): (a) The guidelines issued to all State Governments/Union Territory Administrations for celebration of the Independence Day, inter-alia, prescribe ceremonial unfurling/hoisting of the National Flag at State, District, Sub-Divisional/Block and Panchayat levels. As regards the Republic day, the pattern of celebrations in the Capital which includes unfurling/hoisting of the National Flag is communicated to the State Governments/Union Territory Administrations with a request to ensure that the day is suitably celebrated.

(b) According to the information furnished by the State Government with a view to avoiding breach of peace the Police had to prevent the BJP workers from hoisting the National Flag on 26th January, 1993 at Vadakkanchery because the site chosen by the BJP was very close to the Mananam Maidan, Vadakkanchery town which had permitted by the authorities to be used by Congress (I). The BJP members finally hoisted the National Flag at Vadakkanchery—Alathur Road Margin near Police Station as agreed and dispersed peacefully.

(घ) इस प्रयोजनार्थ गठित किये गये जांच-आयोग के प्रतिवेदन पर अब तक क्या कार्यवाही की गई है?

गृह मंत्रालय में राज्य मंत्री (श्री राजेश पायलट): (क) और (ख) श्रीलंका सरकार से अभी तक कोई अनुरोध नहीं किया गया है।

(ग) और (घ) सूचना एकत्र की जा रही है तथा उसे सदन के पटल पर रख दिया जाएगा।
