श्री एस. एस. अहलूवाविया: हमने कल ही मांग की सदन की तरफ से ग्रॉल पार्टी डेलीगेशन जाना चाहिये ग्रीर वहां पर... (व्यवधान) राज्य सभा जो कौंसिल ग्राफ स्टेट्स है यहां से ग्राल पार्टी डेलीगेशन जाना चाहिये ग्रीर साथ ही केन्द्रीय सरकार की हाई पायर कमेंटी भी जानी चाहिये।...(व्यवधान)

उपसभापति : स्रभी बैठिये प्लीज ।

SHRI JAGESH DESAI: Madam, what is the problem with this Government?

SHRI GURUDAS DAS GUPTA: Madam, call for Mr. Chavan immediately. Mr. Chavan, must be called immediately.

THE DEPUTY CHAIRMAN: Mr. Gupta, please take your scat. If the House agrees that a committee should be constituted consisting of all parties and that committee be deputed to Bihar for fact-finding mission, the best way for all of you would be to discuss the matter with the Chairman and request him to constitute a Committee. If everybody agrees, then, it is fine. Now let us go ahead with the other business.

SHRI S. S. AHLUWALIA: Madam, a Central team from the Ministry of Agriculture should accompany this committee.

THE DEPUTY CHAIRMAN: Now, the matter is over... (Interruptions)... Let me catch my breath. Let me look at the papers which I have got here. We have solved one problem. Let me see what are the concerns of the Members regarding other matters.

SHRI V. GOPALSAMY (Tamil Nadu): Madam Deputy Chairman,...

THE DEPUTY CHAIRMAN: I will permit you.

RE. APPOINTMENT OF A KAN-NADA INTERPRETER IN RAJYA SABHA

SHRI H. HANUMANTHAPPA (Karnataka):

I do not want to give a notice to speak in Kannada language. If they do not want to listen to my plea, I want to close my mouth. I am sorry to say that since ten years I have been pleading for appointment of a Kannada Interpreter in this House. But I have failed... (Interruptions)...

SHRI YASHWANT SINHA (Bihar): Madam, it is a very serious matter. We support Mr. Hanumanthappa for appointment of a Kannada Interpreter in this House.

SHRIMATI KAMLA SINHA (Bi-har): We all support Mr. Hanumanthappa.

SHRI H. HANUMANTHAPPA: Yesterday, I had raised this matter.....(Interruptions)...In this connection, a file moved. But there is an effort to scuttle this move on the plea as to how many times the Members have spoken in Kannada and how many Members have given notice to the Secretariat to speak in Kannada. They come and plead with me, "Why don't you speak in English? We are unable to arrange an Interpreter from the Lok Sabha Secretariat. We

cannot bring him from the Lok Sabha. He is busy there." This was the plea given to me. Today they want statistics as to how many times we spoke in Kannada. Henceforth we will speak only in Kannada language. You must arrange for an Interpreter. If you insist on statistics, from now onwards we will speak only in Kannada. This is Rajya Sabha. This is Rajyon ka Sabha. Unfortunately, my State is being discriminated against by not appointing a Kannada Interpreter in this House. I cannot tolerate it any more

SHRI G. SWAMINATHAN (Tamil Nadu): Our Members will follow you.

SHRI H. HANUMANTHAPPA:

THE DEPUTY CHAIRMAN: I cannot understand what he is speaking.

SHRI YASHWANT SINHA: We must have interpretation.

SHRI S. S. AHLUWALIA (Bihar): Madam, there is no interpretation. He is abusing everybody.

श्री कैलाश नारायण सारंग (मध्य प्रदेश): बोलिये, बोलिये, ग्रपनी भाषा में बोलिये....(व्यवधान)

श्री शंकर दयाल सिंह (बिहार): यहां कितने सदस्य हैं उनको चाहिये कि वे अपनी भाषा में बोलें। अंग्रेजो छोड़-कर सभी भारतीय भाषाओं में बोलें। हम लोग इसका स्वागत करते हैं... (ड्यवधान)

SHRI JOHN F. FERNANDES (Goa): Madam, I have a similar problem. There should be interpretation in Konkani also. (Interruptions).

THE DEPUTY CHAIRMAN: Please, let there be order in the House.

हनुमंतप्ता जी ने जो बात उठाई है कल्नड़ की कि कल्नड़ लेखेज में इंटरप्रटेशन होना चाहिये, मैं इस बात में पता लगाऊंगी सेन्नेटेरियेट में कि क्या प्राब्लम है ग्रीर उर्द् के बारे में भी ये बात ग्राई है, कोंकणी के बारे में ये बात ग्राई है...(व्यवधान)

SHRI H. HANUMANTHAPPA: Madam, I have some more points on

that. (Interruptions).

THE DEPUTY CHAIRMAN: Please let him speak.

SHRI S. S. AHLUWALIA: Mr. Hanumanthappa, for God's sake, you speak in Hindi or English now.

SHRI H. HANUMANTHAPPA: Yes, but on the assurance that tomorrow, there will be interpretation.

SHRI S. S. AHLUWALIA: Yes. (Interruptions).

SHRI H. HANUMANTHAPPA: I have been a Member here for the last 11 years. (Interruptions).

SHRI S. MUTHU MANI (Tamil Nadu): All the regional languages should be interpreted here. Members should have the option to speak in their regional languages. (Inetrruptions).

SHR? H. HANUMANTHAPPA: India is not only the Hindi belt, India is there down south also.

SHRI YASHWANT SINHA: We support you.

SHRI H. HANUMANTHAPPA: India is not just Uttar Pradesn, Madhya Pradesh and Bihar. It means Karnataka, Andhra Padesh, Kerala and Tamil Nadu also.

SHRI YASHWANT SINHA: Mr. Hanumanthappa, we support you. (Interruptions)

THE DEPUTY CHAIRMAN: Order, please. (Interruptions) I said 'order'. I am not allowing anything more on this. Nothing is going on record because there is no interpretation. (Interruption) I do not know your language. I cannot say in that language. Please take your seat. (Interruptions) Nothing is going on record Now, my ruling is that I will find out. (Interruption). Mr. Hanumanthappa, I am not allowing

SHRI H. HANUMANTHAPPA: Madam, let me speak in English now.

SHRI PRAMOD MAHAJAN: (Maharashtra). That is the precise problem. Unless Members from different States speak occassinaly in their own languages, the Secretariat does not keep interpreters on its pay-roll. That is the basic problem. I totally support Mr. Hanumanthappa. But, at the same time, we Members also should speak in our own languages. For five years, if nobody speaks in Tamil in the House, definitely it creates problems for the Secretariat. So, I would also request all the Members to occasionally in their own languages so that the Secretariat can have its permanent translators, interpreters, for them. That is our duty also.

SHRI J. P. JAVALI (Karnataka): I support Mr. Hanumanthappa.

शाहर दय स सिंह : महोदया कहना चाहता हूं कि हम सब में बोलें लेकिन विदेशी ग्रपनी भाषा भागमें न बोलें...(व्या:धाप)

THE DEPUTY CHAIRMAN: Mr. Hanumanthappa, please take vour seat Don't get so agitated.

SHRI H. HANUMANTHAPPA: I am not allowed to speak. I have a point. (Interruptions)

THE DEPUTY CHAIRMAN: Please do not make fun of everything a Mernver raises in the House. It is a serious matter.

SHRI H HANUMANTHAPPA: Mr. Mahajan has taken up advocacy of the Secretagiat. Mr. Mahajan does not know that I tried a dozen times. I gave notice but the inerpreter could not come because there is only one interpreter and he was engaged Lok Sabha. Thrice I tried, but all the time he was engaged. One day was on leave. The other day when I sent for him, he was not present. I have tried a dozen times. So don't say that since we do not speak in the regional language, that is why Secretariat has a problem. Mahajan, don't tell me all this. point is, when I made some efforts, the file was moved. But later on, I came to know that the Secretariat is examining the justification of providing the interpreter. They were examusing as to how many times the Member has spoken in Kannda and whethe there is ay necessity of providing I don't blame anythe interpreter. body. This is just a bureaucratic routine. That justifies my speaking in Kannada to get an interpreter. I tried a dozen times but that was not noticed. That is not on record. The Director or whosoever is examining the matter, naturally, is finding it out from the record and nowhere I nave spoken in Kannada. My speech in Kannada has of been recorded. Their finding is, since nobody has spoken in Kannada, no interpreter is required. (Interruptions)

THE DEPUTY CHAIRMAN: Harumanthappa. I have understood your point and I promise that I am going to look into it.

SHRI H. HANUMANTHAPPA: I want a direction from you. Today, we are on the penultimate day. To-

morrow is the last day of this Session During the next Session, the interpreter should come. It is not so difficult. When we can run the Government of the country, can't we find one interpreter? Is it so difficlut to get an interpreter? Does it require ten years to get an interpreter? So from next Session, if the interpreter is not arranged, we are going to speak only in the regional language. (Interruptions) Finally, I want to bring one fact to the notice of the other members about the interpretation system. If Mr. Mahajan speaks in Marathi, his speech is translated from Marathi into English and from English into Hindi. That is what is happening. You do not know this thing, Mr. Gurudas Das Gupta. If you speak in Bengali, then your speech translated from Bengali into English and then from English into Hindi. (Interruptions)

THE DEPUTY CHAIRMAN: These matters can be discussed in my Chamber and I have taken full cognigance of your complaint. I agree with you that every Member of the House, who wants to speak in his regional language, should be allowed to do so and the Secretariat must make the necessary arrangement. We will look into the matter. But this matter has come before me for the first time. (Interruptions)

SHRI H. HANUMANTHAPPA: Madam. I have raised it so many times in this House.

THE DEPUTY CHAIRMAN: But not before me. I am presiding now. The file was never put up to me. I am not aware of what is happening. But as you have raised it in the House and it has been raised by other Members also, we will take care of this thing and we will look into it. But now we have to continue with the listed business. If you sincerely want that the money should go to Bihar, then we should finish the listed busi-

ness here and pass the Vote on Account and the Supplementary demands. But we should finish this business first which is pending before us-the Budgets of Jammu and Kashmir, Himachal Pradesh, U.P. and M.P.—we have to pass them. (Interruptions) Now let us not ask clarifications (Interruptions)

Now, I will permit every Member to speak for one minute only. I am looking at the watch.

SHRI V. GOPALSAMY (Tamil Nadu): Madam Deputy Chairman, police repression has been let loose against the farmers of Kovilpatti in Tamil Nadu and two farmers have been killed by the police ... (Interruptions)

SHRI G SWAMINATHAN Nadu): Madam, it is a law and order question of the State of Tamil Nadu. It is not a matter of thise House. How does he raise it in this House? (Interruptions) It is a law and order problem of Tamil Nadu. It should not be allowed to be discussed in this House (Interruptions). It is entirely a matter relating to the State of Tamil Nadu Assembly. The Tamil Nadu Assembly is there to discuss it. (Interruptions)
