Insurance Policy of Passenger by Railways

- (a) whether passenger insurance is being introduced by the Indian Railways from the next financial year;
- (b) if so, the salient features of this policy and when it is likely to be introduced; and
- (c) what provision in this regard is being made in the Railway Budget for the year 1993-94 to meet the insurance premium expenses indicating also the provisions made during the current year?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI K.C. LENKA): (a) Yes, Sir.

(b) Presently under the provisions of Section 124 of the Railways Act, 1989, only the victims of passenger train accidents are entitled for compensation. The Railways, however, propose to provide an insurance scheme to cover incidents of deaths4njuries to bonafide passengers on account of terrorist attacks, dacoities, bomb blasts etc... including the

railway staff travelling on duty or on railway passes.

The scheme is likely to be implemented by October, 1993.

(c) The annual premium to cover claim on above account is estimated to be approximately Rs. 8 crores. This amount will be provided in the year 1993-94 at the Revised Estimates stage. As the scheme itself has been proposed to be implemented from 1993-94, no provision for the same has been made in so far as the current year is concerned.

Railway lines to J&K, Punjab and Haryana
