The other point is that Mr. Padmanabham insisted that the Railway Minister should make a statement in the House. I agreed. After that 1 went and discussed this matter with the Railway Minister. He said that he was willing to come and clarify all the doubts about it in the minds of the Members. Subsequently I told the Parliamentary Affairs Minister, Margaret Alvaji, also and I also told Mr. Padmanabham that day ... (Interruptions) I know, I know.

SHRI MENTAY PADMANABHAM: Yesterday itself we raised this issue, Madam, and then you clarified it.

THE DEPUTY CHAIRMAN: Yesterday also. You raised it the day before yesterday also. You raised it yesterday also. I observed. 'As there is a lot of pending Government Business, we cannot take it up today or tomorrow. We may take it up when the Railway Minister comes to the House to reply to the discussion on the Railway Budget which we had in the House." This is the thing.

It is a part of the record. I am sure, the Chairman knows about it, that this is a part of the record. The Chairman is not so ill-informed, I must inform the Member who said that the Chairman might not be knowing about it. There is nothing which the Chairman does not know of. Everything I sincerely report to the Chairman. So, the Chairman knows about it. The Chairman, in his wisdom, has allowed some matter to be raised by Mr. Gurudas Das Gupta. I am not aware of what issue he is raising. I cannot know about at until and unless he raises it. If there is aything objetionable, I assure the House that I will rot allow if to go on record.

Now that we have got over our technical problem. I think, Mr. Gurudas Das Gupta, within those parameters if you want to speak, please speak.

RE IRREGULARITIES IN THE AWARD OF CONTRACT BY THE RAILWAYS

SHRI GURUDAS DAS GUPTA: The main point is irregularity in the award of contract by Railways. The first point is- that the Railways had offered to a firm manufacture of sleepers as far back as in 1988. After one year, in 1939, the offer of the contract was given Rayalaseema Sleepers. The Rayalseema Sleepers were categorically told that they will have to manufacture the sleepers in a particular place. Chan-takani is the place where they were to manufacture these sleepers. That was under the contract given. But the contract was not met by the firm to which it was Where is the irregularity? In 1988, awarded. the offer of contract was made by the Railways, in 1989, the contract was given to a firm, but for four years that firm does not agree to enter into a contract with the Railways It was an unusual delay of five years. Why was the The delay was because the firm to delay? which the contract was given did not agree to locate the manufacturing unit in that place, where theV were asked to do it by the Railways because that place was a place infested by militant activities. Therefore, 'for five years the contract remained pending and for five years there was a war of correspondence between the Rayalaseema Sleepers and the South-Central Railway. This situation undergoes dramatic change in 1992. That gives rise The dramatic change takes suspicion. place because suddenly a partnership formed. This partnership is known as V. S. This Engineering. partnership, according to my information, according to the papers that 1 have with me was formed on 6th April, 1992. I have with me the Partnership Deed. I have also with me the Income-Tax Clearance. Both papers show that the partnership was formed on 6th April, 1992. Incidentally, in the Income-tax clear ance it is shown that the Managing





THE DEPUTY CHAIRMAN; It is not so. There are very many important matters lying here... (Interruptions) ... because the agreement was that as long as we had to finish any financial business., we were not going to have the lunch hour... (Interruptions) ...

भ्राप बोलिये, भ्राप भ्रपना समय वधों नष्ट ें SHRI S. JAIPAL REDDY: Madam the point or order raised by Mr. Bhandare is not relevnt in this context. .. {Interruptions} ...

SHRI SUSHILKUMAR SAMBHAJIRAO SHINDE (Maharashtra): Madam, on the decision of the Deputy Chairman there cannot be any point of order... (Interruptions) ... On the point of ordar raised by Mr. Bhian-dare, you have given your decision and there cannot be any point of order on that... (Interruptions) . . .

THE DEPUTY CHAIRMAN: I am only saying that the Chairman has not permitted... (Interruptions) ...

SHRI SURESH KALMADI: Madam, the High Court itself has stayed it. How can they discuss it? ... (Interruptions) ... The High Court itself has stayed it... (Interruptions)... how can they discuss it? It is going too far... (Interruptions)...

THE DEPUTY CHAIMAN: Mr. Murlidhar Bhandare referred to a section of the Act and said that this cannot be mentioned. That is what he referred to... (Interruptions)...

SHRI S. JAIPAL REDDY: Madam, I am not being allowed to respond to the point of order of Mr. Bhandare. .. (*Interruptions*). . .

THE DEPUTY CHAIRMAN: Please let me restore order in the House... (Interruptions)...

SHRI S. JAIPAL REDDY: As a protest against the obstructionist tactics of the Congress (I), we stage a walk-out.

[At this stage, some hon. Members left the Chamber].

THE DEPUTY CHAIRMAN: The House is adjourned *tor* lunch till 2.30 p.m.

The House then adjourned for lunch at thirty-one minu-tes past one of the clock.

The House re-assembled at thirty-three minutes past two of the clock.

[The Vice Chairman (Syed Sibtey Razi) in the Chair].

THE VICE-CHAIRMAN (SYED SIBTEY RAZI): Chairman has given permission to certain hon. Members 10 speak. So, I am calling them. I would request Members to take the minimum time, Shrimati Sarla Maheshwari.
