including hinterland areas of the State from 15.2.93 to 17.2.93 Although, he met a large number of people from different walks of life, no talks were held with the leaders of militant outfits.

- (b) In view of the above, the question does not arise.
- (c) Efforts to talk to various people and groups of people with a view to activising the political process and bringing about normalcy in the State will continue.

Rs. 10 crores has also been released to the State Government during 1991-92 as grants in-aid for operation against militants. Further, the Central Government have declared LTTE as an unlawful association under the Unlawful Activities (Prevention) Act, which will strengthen the hands of the State Government in containing the activities of LTTE.

Raising More Battalions of Women in CRPF
