- (घ) यदि इस संबंध में कोई जांच की गई है, तो उसका ब्यौरा क्या है स्रौर उस पर सरकार की क्या प्रतिक्रिया है?

मानव संसाधन विकास मंत्री (श्री अजन सिंह) : (क) जी, हां ।

(ख) से (घ) उत्तर प्रदेश सरकार से मिली रिपोर्ट के अनुसार, दिलांक 13-2 93 को दोपहार 12.30 बजे, मुरादावाद में मुहल्ला कटरा बंशीधर स्थित यज्ञ भवन जुनियर हाई स्कूल की तिमंजिली इमारत की छत गिर गई, जिसके परिणामस्वरूप 23 बच्चों ग्राँर 4 शिक्षकों सहित 28 व्यक्तयों की मृत्यु हो गई। इसके अतिरिक्त 19 बच्चों तथा एक शिक्षक सहित 23 लोगों को चोटें ग्राई । दुर्घटना के त्रन्त बाद, स्थानीय पुलिस तथा स्थानीय लोगों ने मलवे में से बच्चों को बाहर निकालने में हर सम्भव सहायता की। घायलों को उपचार के लिए मुरादाबाद के यदी दीनदयाल उपाध्याय अस्पताल कराया गया । भारतीय दण्ड संहिता की धारा 338 तथा 304 "ए" के ग्रंतर्गत विद्यालय प्रबंध समिति के प्रदेधक तथा दो सदस्यों को गिरफ्तार कर लिया गया राज्य सरकार द्वारा प्रत्येक मृतक परिवार को 20,000/- रुपए तथा प्रत्येक घायल के परिवार को 2,000/- रुपये ग्रनग्रह राशि के रूप में मंज्र किए गए। भविष्य में इस प्रकार की दुर्घटनाम्रों को रोकने के लिए, राज्य मरकार ने मुरक्षा दिष्ट से सभी जिला मजिस्ट्रेटों तथा जिला शिक्षा ग्रधिकारियों को सभी स्कूलों का निरीक्षण करने के लिए निर्देश किए।

नवीनतम उपलब्ध य्रांकडों के य्रनुसार, लगभग सभी स्कूलों की व्यवस्था राज्य य्रथवा केंद्र शासित क्षेत्रों के प्रशासनिक नियंत्रण के य्रधीन होती है जो संबंधित स्कूल शिक्षा य्रधिनियम प्रथवा उनके य्रतंगत बनाए गए नियमों के प्रनुसार प्रपने-अपने कार्य-क्षेत्र। में स्कूलों को नियंत्रित करते हैं। स्कूल शिक्षा का कोई केंद्रीय प्रधिनियम नहीं है। अतः उत्तर प्रदेश सरकार भविष्य में स्कूल के छात्रों के हित में यब उत्तर प्रदेश में प्रचलित स्कूल शिक्षा के राज्य अधिनियम के उपयुक्त प्रावधान या उसके ग्रंतर्गत निर्मित नियमों के अनुसार ग्रागे की कार्यवाही कर सकती है।

Subsidy for Revised pay Scales of Teachers in Bihar

1427. SHRIMATI KAMLA SIN-HA: Will the Minister of HUMAN RE-SOURCE DEVELOPMENT be pleased to state:

- (a) whether it is a fact that Government have withheld Rs. 40 Crores due to the Government of Bihar as subsidy for the revised pay scales of tearhers;
- (b) if so, what are the reasons therefor; and
- (c) by when the amount withheld is proposed to be released?

THE MINISTER OF HUMAN RE-DEVELOPMENT (SHRI SOURCE ARJUN SINGH): (a) to (c): In pursuance of the National Policy on Education-1986, Government of India announced in June, 1987, a scheme of Revision of Pay Scales of teachers in universities and colleges and measures for maintenance of staneducation. dards of higher Government also decided ot provide financial assistance to the State Governments to the extent of 80 per cent of the additional expenditure involved in implementation of the Scheme. Central asisstance was to be provided for the period from 1-1-1986 to 31-3.1990. The payment of Central assistance was subject to the condition that the entire Scheme of revision of pay-scales together with all the conditions attached to it, is implemented by the State Governments as a composite scheme without any modification except to the date of implementation and the scales of pay.

In pursuance of this, Government of Bihar formulated a scheme revision of pay scales of teachers universities and colleges in the State and submitted it to the Central Government in June, 1990, for approval On examination of the State Government's scheme, it was found that certain provisions were not in conformity with the Government of India's Scheme. The State Government has since been requested to make necessary changes in the Scheme so that the admissible Central assistance could be relesaed to it for its implementation.

Approval of a Scheme of Advanced Study in Botony in Cuttack

- (a) whether it is a fact that University Grants Commission has approved a scheme of advanced study in Botany in Revenashaw College, Cuttack in memory of Dr. Pranakrughna Parija, a great scientist; and
- (b) if so, what are the details thereof?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) According to information furnished by UGC the commission received a proposal from Revenashaw College, Cuttack in September, 1991 for upgradation of Parija Po t-graduate Department of Botany for the level of a Centre of Advanced Study (CAS). The propo-

sal envisages an outlay of Rs. 1.17 erores.

However, due to constraint of resources, the Commission did not take up for consideration any such proposal for new sanctions under the UGC scheme.

Urdu Primary Schools run by NDMC

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b): According to the information furnished by New Delhi Municipal Committee there is one Urdu Medium Primary School run by the Committee and in 9 other Primary schools Urdu Medium classas are being run parallel with Hindi Medium classes.

(c) and (d): According to the information furnished by Delhi Administration admission in class VI onwards is given through the Admission Plan based on the neighbourhood concept keeping in view the number of students studying in primray classes run by local bodies in a psecific locality and also the students likely to seek admission from the neigh-
