Madhya Pradesh Primary school teachers are given training in all school subjects while upper primary teachers get subjectwise training. Primary school teachers are also being oriented in use of materials provided under Operation Black Board.

### Change in the Admission system of Nursery School Children

1466. SHRIMATI CHANDRIKA
ABHINANDAN JAIN: Will the
Minister of HUMAN RESOURCE
DEVELOPMENT be pleased to state:

(a) whether Government propose to change the admission system of nursery school children so that they are not subjected to traumatic admission tests; and

(b) if so, the details thereof?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) The NCERT has been strongly advocating the need to change the system of admission to nursery schools so that the children are not subjected to the trauma of admission tests. The NCERT has been regularly organising seminars at different places to create public awareness in this context. Programme of Action (1992) for implementation of NPE also calls for discouraging entrance tests for admission at pre-primary level. Necessary action in this regard is to be taken by the respective State Governments/ Administrations in accordance with their rules and regulations. In Delhi the Directorate of Education modified its admission system in 1991 to computerized random selection. A few leading schools of Delhi and some schools in other cities also have since adopted alternative methods like randomized selection selection throug comprhensive proformae and quotabased randomized selection.
