Procedure covering the Sahitya Aka demi Prize for Translation

- 1 Entries are invited from individual publishers through translators or advertisement in the leading news papers throughout the country. Be sides the members of the twenty two Lauguages Advisory Board are requested to send nominations. A ground list may also be got prepared by an expert in each language. In casbe of difficulty in receiving the ground that the Regional Offices of the Akademi may be asked to compile a lis of translations published during the period in the languages handled by them. The Library in the Head Office may compile such a list in respect of the remaining languages.
- 2. Initially only one copy of the entry be procurred on purchase basis either from the translators or through the Advisory Broad members who recommends the translator along with a certificate that:
 - (i) it is a full and unabridgesed translation:
 - (ii) the translation is faithful to the original work;
 - (iii) it is a direct translation/it is a translation done through a link language;
 - (iv) the standing of the original writer and the excellence of his book would also have to be certified
- 3. A three-Member Target Language Export Committee would be formed to short-list the entries and reduce them to not more than Ave, received in each language.
- 4. Three more copies of the books from the short-list would be procured and stop to the members of the Selection Committee for giving their re-comendations in a prescribed profor-ma in order of preference.

- 5. Along with staements of opinion the three members of the arget Lan-gauge Committee would send a detailed report at least thre half sheet pages full ,stating the reasons why the first, second or tird preference (and more if any) is given to a particular work, elciting one or two instances of excellence in the use of language of translation in words, sennce construction, idiom and chang or modification of magery and how far the thesu are maintained over the entire book. The size of the translation and the translated book should also be commented upon. It should also be reported whether the language used for translation has a standard and can be generally understood by the common reder.
- 6. The statements of opinion received from the threr members of the Target Language Committee would be placed before the Executive Board of hte Sahiya Akamedi which will declare the Prize on the basis of the recommendations of the members of the Target Language Committee.

Convention on the Rights of Child

Rights of the Child. The instrument of accession was deposited with the UN Secretary General at New York on 11.12.1992.

(b) The Convention consists of a Preamble and 54 articles giving economic, social and cultural rights to children.

THE MNISTER FOR HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (e) A large number of applications and requests from individuals and various quarters for consideration for appointment to teaching and non-teaching posts in different Vidyalayas are received from time to time. Such requests are sent to the Head Office of the Sangathan for action as per procedures and rules. Depending on the category of

vacant posts available from time to time, the vacancies are also advertised 'oy the regional offices or Headquarters of the Sangathan and candidates pensorea[registeMdt With Emp. ment Excnriuges are also considered for specific categories, All applications are scrutinised with reference to the minimum eligibility conditions laid down such as educational quali fications, experience, age limit, etc. Duly constituted Selection Committees assess the suitability of candidates through interviews whenever necessary. The regional offices and the Headquarters of the Sangathan are required to follow all the procedures and rules in respect of all appointments irrespective of any recommendations regarding individual applicants.

(f) The Assistant Commissioner at Regional Office, Bhopal who attained the age of superannuation on 30.11.92 has been granted extension because of administrative requirement and in view of unfilled vacancies of Assistant Commissioners
