Relief to a Freedom Fighter

1854. SHRIMATI KAMLA SINHA : DR. BAPU KALDATE :

Will the Minister of HOME AFFAIRS be pleased to state :

(a) whether it is a fact that a case for relief to the family of a freedom fighter Safdar Ali Beg "Bagi" of Shikohabad (UP) who was hanged by the British *Government* and whose property was attached has been pending with Government for more than elven years despite the repoits of the District Magistrate/Commissioner and the President Legal Aid and Advice-Cell of U. P. Government;

(b) if so, what are the reasons for in ordinate delay in taking a decision in the matter; and

(c) what is the present position and what measures have been taken to expedite the case to give relief to his family in dis tress ?

THE, MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI

P. M. SAYEED) : (a) Under the provisions of the Swatantrata Sainik Samman Pension Scheme, family pension can be sanctioned only to Che widows and tmmar-ried & unemployed daughters of such of the freedom fighters who have died. Government had received an application from One Shri Syed Shabih-ul-Hasan Naqvi, claiming himself to be the son of late Smt. Kulsoom Begum, great grand daughter of the late Shri Safdar Ali Vakil 'Bagi', for grant of pension. As Naqvi is not eligible to get the freedom fighters pension under the provisions of the Scheme, it is not possible to grant the same. Shri Naqvi has already been informed of the decision of the Government.

(b) and (c) Do not arise.

Curbing of ULFA

1855. SHRI PARMESHWAR KUMAR AGARWAIXA : Will the Minister of HOME AFFAIRS be pleased to state :

(ai) whether it is a fact that Government have recently started a massive offensive against ULFA with the help of Army;

(b) if so, whether any headway has been made in curbing the ULFA activities; and

(c) if so, the achievements made so far in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. M. SAYEED) : (a) Operations by the Security Forces are continuing against the anti-taik faction of the ULFA.

(b) and (c) The said operations have considerably curbed violent activities of the

ULFA. A number of their activists have surrendered expressing their loyalty to the Constitution of India and commitment 10 abjuring violence.

Attempt to smuggle arms into India foiled, by Indian Troops

(a) whether it is a fact that Indian troops on 3rd February, 1993 foiled an attempt of Pakistani agencies to push arms suppliers into Kashmir Valley and recover ed the largest ever consignment of am munition and hand grenades;

(c) whether anybody was nabbed in the attempt ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI RAJESH PILOT) : (a) to (c) On 3rd February 1993, in Uri Sector along the Line of Control in Jammu and Kashmir, a group of infiltrators was intercepted by the Security Forces. On being challenged they fled back into POK. During the subsequent search of the area by our troops, the following arms and ammunition were recovered :—

- (c) Hand Grenades 1120
- (d) Ammunition (rounds) 15285
- (e) Anti personnel mines 19
- (f) Exp'osive materials

Governments is not maintaining any separate record of the cases of ireaom nguiers who have been sanctioned pension but nave not been made the actual payment. The pensioners are also not required to intimate as to whether they have started receiving pension or not. As and when cases involving delays in actual payment are brought to the notice of the Government, remedial action is taken.

Fire service in Delhi
