Facilities of Drinking Water at various Railway Stations

In the summer season at certain stations difficulty may arise some times due to overall reduced availability of water, power cuts and break downs. In order to overcome these problems railways take necessary measures which include review of the water supply arrangements before the onset of summer season and to make the system ready for likely eventualities, transportation of water by rail/road and provision of water trollies and gharas or wheel barrows. Wherever considered necessary, hot weather watermen, in addition to the regular watermen, are also pi-essed into service during summer.
