THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPTT. OF CUL-TURE (KUMARI SELJA): (a) and (b) According to the information furnished by the University of Delhi, the fire-fighting system has not yet been commissioned in the building of the University's Science Instrumentation Centre causing DESU not to provide the required amount of electricity to the Centre. All the instruments in the Centre cannot therefore be used simultaneously, leading to some instruments being under-utilised.

(c) Efforts are being made to complete the remaining work on the fire-fighting system after which the requisite electric power supply would be possible enabling full utilisation of the instruments

Assistance for establishment of Sports School
