Conversion of Agriculture land for aquaculture in Andhra Pradesh***254. SHRI G. PRATHAP REDDY:****DR. SHRIKANT RAMCHAN. DRA JICHKAR:**

Will the Minister of AGRICULTURE be pleased to state:

(a) whether it is a fact that large amount of agriculture land is being converted into land for aquaculture in the coastal areas of Andhra Pradesh due to which the production of paddy has declined in the State;

(b) whether it has created an imbalance in the agricultural crop pattern in this State; and

(c) what corrective action is being taken by Government to stop this switch-over?

THE MINISTER OF STATE IN THE MINISTRY OF NON-CONVENTIONAL ENERGY RESOURCES WITH ADDITIONAL CHARGE OF THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI S. KRISHNA KUMAR): (a) The State Government have reported that the extent of conversion of paddy fields into fish ponds is very negligible. Hence the decline in paddy production cannot be mainly attributed to conversion of paddy lands for aquaculture.

(b) No, Sir.

(c) The State Government has constituted a Committee under the Chairmanship of Commissioner, Land Revenue, for studying the issue.

Distribution of Fertilizers in Assam

*255. SHRIMATI BASANTI SARMA: Will the Minister of AGRICULTURE be pleased to state:

(a) the quantity of Urea and Phosphatic fertilizers distributed among the small and marginal farmers in Assam in each of the last two years;

(b) the number of farmers benefited in the State, district-wise;

(c) whether Government have received complaints regarding irregularities in distribution of fertilizers in the State; and

(d) if so, the action taken thereon?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ARVIND NETAM): (a) The scheme for distribution of Urea, Phosphatic Fertilizers, etc. to small and marginal farmers was taken up in 1992-93. The State Government of Assam did not implement the scheme.

(b) Does not arise.

(c) and (d) No complaints have been received regarding irregularities in the distribution of fertilisers in the State.

शहरी विकास मंत्री (श्रीमती शीला कौल) : (क) जी, हां।

(ख) उत्तर प्रदेश जल निगम से हल्द्वानी, अलमोड़ा, नैनीताल, काशीपुर तथा लखनऊ शहरों के लिए जल आपूर्ति सहित मल निकासी की योजनाएँ सातवीं पंचवर्षीय योजना के दौरान मिली थीं। इन योजनाओं की अनुमानित लागत इस प्रकार है :—
