cotton growers to get a reasonable price for their produce. The Government have also released an export quota of 14,995 lakh bales of cotton, of which 15,000 bales have been allotted to the Karnataka State Cooperative Marketing Federation. This has helped in stabilishing cotton prices.

## Assistance for increase in Bice Production

- 2133. SHRI V. HANUMANTHA RAO: Will the Minister of AGRICULTURE be pleased to state:
- (a) what steps are being taken to increase rice production by increasing productivity;
- (b) whether State Government of Andhra Pradesh has asked for any special assistance to increase produe, tivity in rice cultivated areas; and
- (c) if so, the details of any specific assistance offered to Andhra Pradesh in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ARVIND NETAM): (a) The steps being taken to increase rice production by increasing productivity include:

- (i) increase in area under location specific high yielding varieties;
- (ii) increased/efficient use of in puts like fertilizers. irrigation. water micro-nutrients herbicides, etc.:
- (iii) effective control of insect pests and diseases through adoption of Integrated Pest Management (IPM) Approach and need based use of pesticides;
- (iv) transfer °f improved rice production technology through reorganised T and V system and through organising field demonstrations and farmers' trainings.
- (v) Marketing support and remunerative prices to farmers for their surplus paddy produce; 490 R.S.—3

(vi) developing the on farm re-ources like irrigation facilities, farm machinery and implements, etc.;

- (vii) providing credit to needy farmers for facilitating crop cultivation.
- (b) and (c) A Centrally Sponsored "Integrated Programme for Rice Development" is being implemented in the State on 75:25 sharing basis, between GOI and State. Except for the assistance under this scheme, State has not asked for any other special assistance for increasing the productivity of rice.
