(b) National Airports Authority have incurred an expenditure of Rs. 92.31 lakhs.

(c) Government have approved a scheme for provision of helicopter service by Pawan Hans in this region.

THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI GHULAM NABI AZAD): (a) No, Sir.

(b) to (d) As and when incidents of crime against foreign tourists including foreign women tourists are reported the law enforcing agencies take suitable action on the matter. Appropriate measures are taken to prevent such crimes. Tourist Police Booths have been set-up and tourist police vehicles have also been stationed at strategic locations Department of Tourism also takes up the matter with concerned authorities as and when complaints of foreign tourists are received.

traffic demand. Indian Airlines has no plans at present to restore the service;
